Quotation/Tender Call Notice

Sealed quotations/tenders are invited from interested reputed Travel Agencies/Tour Operators or private individuals for providing 01 nos. of AC Diesel driven vehicle preferable "INNOVA" having sitting capacity not more than ten including driver. Which shall conform to the Terms and conditions (Annexure-II) for official use in Land Acquisition Office, Collectorate, Dhenkanal on monthly rent basis:

1. The vehicle must be in Road Worthy condition, shall not be more than 1 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for playing of vehicle.
2. The Driver of the vehicle must have a valid driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle
3. The driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs.5,000/- shall be deposited by the intending bidders in shape of Account Payee, Bank Draft drawn in favour of the Land Acquisition Officer, Collectorate,, Dhenkanal and submitted along with the tender as security deposit. After completion of the tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants)
6. The Vehicle must achieve a fuel efficiency of 10 Kms per liter.
7. The details of the make and year of manufacture of the vehicle, registration No, millage(Kms covered per liter)and name of the driver with driving license no and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender(Annexure-III).
8. The sealed Quotation completed in all respect should reach the undersigned by Registered Post/Speed Post only on or before 20.04.18 by 12 Noon and shall be opened on the same day at 12 30 PM in presence of the bidders or their authorized representative. The sealed envelope must be superscribed with "Quotation for hiring of Vehicle".

The application form of quotation/tender containing General Bid Information and Terms and conditions for Hiring of Vehicles etc, will be available with Land Acquisition Office, Collectorate, Dhenkanal on payment of Rs. 100/- from 10.04.2018 to 20.04.2018 or can be downloaded from District Office Website, www.dhenkanal.nic.in from date 10.04.2018 to 20.04.2018 up to 12 Noon. In case of the application form is download from the above Website, the applicant shall furnish a Demand Draft for an amount of Rs 100/-(Rupees One Hundred only) towards the cost of application along with the application.
