Terms and Conditions :

- The appointment is purely temporary & can be terminated at any time without notice or assigning any reason thereof.
- Their contractual service shall be renewed every year basing on their satisfactory performance and can be regularised on completion of 6 (six) years of continues of service.
- They are entitled to leave under the provisions of the Odisha leave Rules – 1956.
- She shall abide by the Odisha Civil Service Conduct Rules-1959 and OCS (C.C & A) Rules-1962.
- They should report for duty before the concerned CDPO within 15 days from the date of issue of appointment order, failing which the appointment shall automatically be cancelled and they will not claim for any further appointment in this establishment.
- Candidates are required to produce the following documents to the concerned CDPO at the time of joining, failing which joining report shall not be accepted.
 - a) Medical Fitness Certificate signed by the Govt. Medical Practitioner not below the rank of Asst. Surgeon.
 - b) Two Passport size self attested photographs.
 - c) Certificate of educational qualifications and certificate showing the date of birth.
 - d) Two character certificates from two gazetted officers.
 - e) Marital declaration, if married, having not more than one spouse living.
 - f) Caste certificate in original in case of SC, ST & SEBC candidates.
 - g) SEBC certificate in original issued within one year.
 - h) Oath of allegiance to the constitution of India.
- No travelling allowance is admissible to join in the post.
