3. The company should be able to rectify or replace the items as and when required within the stipulated time.
4. The contractor should have adequate at least two years work experience of installing CCTV, preferably in 2-3 Govt. Offices/ big companies and should submit the supporting documents including performance certificates given by the Govt./ other Organizations
5. Tenders have to be submitted duly filled in and signed by authorized person in ink pen or ball pen. Tenders written in pencil or erased/over-written will not be considered.
6. The bidders shall not be at liberty to offer his/her terms and conditions with regard to the tendered work that means the bidder cannot deviate from the terms and conditions given herein. Otherwise, the tenders are liable to be summarily rejected.
7. The tenderer must be registered with Sales Tax Department and a copy of registration certificate to this effect, duly signed and stamped by the authorized person of the company must be enclosed with the tender.
8. 'GST' No. of the firm as applicable while submitting the tender, must be indicated. A tender lacking this will not be considered.
10. Before submitting the quotations, the inspection can be done on any working day at DHH, Dhenkanal.
11. The rates are to be quoted on the company's letter head. Each page of the quotation/tender must be signed & stamped by the authorized Signatory. Unsigned quotations may not be considered.
12. Technical & Financial bids should be submitted separately in sealed cover and both these sealed covers should be put in a big cover which should also be sealed and super-sealed covers should be put in a big cover which should also be sealed and super-sealed as 'Quotation for installation of CCTV in DHH, Dhenkanal'.
