







ADVERTISEMENT

Applications are invited from the interested vehicles owners for the engagement of Hired Vehicle under Mobile Veterinary Unit, Hindol Block.

The applications should reach the undersigned on or before 16.10.2018 in accordance with the following terms and conditions.

- ❖ The monthly hiring charges of the vehicle is Rs. 16000/- . The fuel cost will be borne by the CDVO as per the operational guidelines of MVU for 2018-19.
- ❖ Priority shall be given for engagement of Jeep type vehicle like Bolero/Marshal etc. for MVU. In any case if Jeep type vehicle is not available in bidding process then Van type vehicle of maximum 3 years old can be selected through bidding process.
- ❖ The vehicle shall be within 3 years old; In case of non-availability of vehicles of 3 years old, the age of the vehicle may be relaxed to 3-5 years. The vehicle should accommodate minimum 3 persons with sufficient space for keeping need based equipment, medicine, chemical, biologicals etc.
- ❖ A driver with valid license should be available as and when required. He should be nonalcoholic.
- ❖ Vehicle should be kept clean and tidy and should have a clearly visible registration Number on it.
- ❖ Vehicle should have valid registration, fitness certificate, insurance etc. and the driver should have a valid Driving license. Agreement will be made with the vehicle owner that the Driver should carry his valid Driving license while driving.
- ❖ Vehicle should be regularly serviced & maintained at the owners cost so as to avoid any break down. In case of inadvertent break down, an alternative vehicle shall be immediately arranged by the owner without compromising the service of Mobile Veterinary Unit.
- ❖ The vehicle must be stickered on front, back & side displaying different flagship programme of the Department.
- ❖ In case of any natural calamity like flood, cyclone, drought, lightning, heat waves, outbreaks of disease, post mortem examination of insured livestock, or other livestock emergency services, MVU vehicle shall move to serve the Livestock and to help the poor farmers. Additional fuel cost for such activities shall be borne by the C.D.V.O.
- ❖ GPS tracking device shall be installed on the vehicle and it will be mentioned in the agreement with vehicle owner. Vehicles of non-willing owners will be rejected.
- ❖ The norms of finance Department shall be followed during selection of private vehicle for MVU purpose.
