**17. DEFINITIONS**

**17.1 GENERAL**

The following expressions here under and elsewhere in the contract documents used shall have the following meanings hereunder respectively assigned to them except where the context otherwise requires:

- 17.2 "Bidder" or "Bidders" shall mean those parties who have submitted their offer to the Owner in response to the Tender.
- 17.3 "Tender Document" shall mean the Tender Documents comprising Part-I (Technical Bid) – Notice inviting tender, General Conditions of contract, Special Conditions of Contract, Technical Specification, Schedule of Quantities, Addenda / Corrigenda to the tender document issued by Executive Officer, Debottar, Dhenkanal Form of Tender and Part II (Financial Bid) – Un priced Schedule.
- 17.4 The "Contractor / Successful bidder" shall mean the bidder selected by the Owner for the performance of the work and shall include the successors and Owner permitted assigns of the Contractor.
- 17.5 The "Sub-contractor" shall mean any person or firm or company (other than the Bidder) to whom any part of work has been entrusted by the bidder with the written consent of the Executive Officer, Debottar, Dhenkanal.

- iii) Final payment @ 10% of the contract value shall be treated as Performance Security and shall be paid against satisfactory performance and maintenance of the one no of 12 feet x 8 feet PH 6mm outdoor fixed L.E.D, Display Screen at Shree Chandrasekhara Temple Bijje, Kapilash under Dhenkanal District during warranty period. This amount shall be paid in five equal annual instalments starting from completion of one year from the date of installation at site on receipt of performance report duly signed by authorised officer from user organisation/ Debottar Office, Dhenkanal as the case may be.
- iv) The payment shall be released after deduction of applicable taxes, and the payment shall be released within 20 days from the date of receipt of certified bill in Debottar Office, Dhenkanal concerned.

**49. STRICT ADHERENCE TO SPECIFICATION & CTE INSPECTION**
