In pursuance to Govt. of Odisha, Health & Family Welfare Department letter no. 25987/H dt. 08.12.16 & no. 26288 dt. 14.12.16 and General Administration notification no. 32010/Gen dt. 12.11.13 & no. 1147 dt. 17.01.14, the following candidates selected by District Selection Board are hereby appointed as Attendants on contractual basis with a consolidated remuneration Rs.8070/- (Rupees Eight Thousand Seventy) only per month as per GA Dept. notification no. GAD-SC-RULES-0037-2017-19574/Gen Dated. 12th September 2017 with the following terms & conditions as envisaged in the notification no. 32010/Gen dt.12.11.13 of General Administration Department, Odisha. They are posted to the medical institutions as indicated against their names. The cost of remuneration shall be met from the state budget (Non Plan / Plan Head of Account). This has been concurred by Finance Department vide their UOR No. 128-SS-III dt. 20.09.16.

The appointment is purely on temporary basis & may be terminated at any time without prior notice & assigning any reason thereof.




1. The candidate should submit the written undertaking in the model form (enclosed) prior to her/his joining in the post as per contractual engagement.
2. She/he shall continue on contractual basis for a period of six years. The period of six years shall be counted from the date of her/his joining in the respective post as per contractual engagement.
3. Subject to satisfactory performance, the remuneration shall be enhanced as per slabs prescribed under the annexure appended in GAD-SC-RULES-0037-2017-19574-Gen. Government of Odisha, General Administration & Public Grievance Department Notification Dated 12.09.17 on completion of each year of service.
4. She/he shall not be entitled to DA, HRA, RCM & other allowances during the period of contractual engagement.
5. On the date of satisfactory completion of six years of contractual service, she/he will be considered for regular appointment. On regular appointment she/he will be entitled to draw the time scale of pay as per appropriate level & cell with DA & other allowances as admissible by Govt. of Odisha.
6. She/he should submit the following documents to the concerned offices at the time of her/his joining in the post failing which the joining report shall not be accepted.
 - a. Medical fitness certificate signed by the Govt. Medical Practitioner not below the rank of Asst. Surgeon.
 - b. Two character certificates from two Gazetted Officers.
 - c. Two self attested pass port size photographs.
 - d. Self attested photo copies of certificates in support of her/his qualification & date of birth/resident/caste.
 - e. Marital declaration, if married having not more than one spouse living.
 - f. Oath of allegiance to the constitution of India.
7. She/he should report for duty before the concerned officers within fifteen days from the date of issue of the appointment order failing which the appointment order shall be automatically cancelled.
8. No travelling allowance is admissible to join in the post.






