**CORRIGENDUM**

In partial modification of the Quotation Call Notice released vide No. 2614/SSD and 2618/SSD Dt. 29.12.2018 inviting sealed quotations for supply of *Stainless Steel Tray and Bed Sheet* respectively, the following specification/criterion have been added. All concerned while submitting quotation/tender should follow the addenda and corrigenda properly.

1. The tender paper can be purchased from the District Welfare Officer, Dhenkanal on payment of Cash of Rs. 4,500/- (Rupees Four thousand five hundred) only for each item/ material separately which is non-refundable on all working days during office hour up to 14.01.2019 and up to 11.00 A.M of 15.01.2019. The tender paper can also be downloaded from the District Website [www.dhenkanal.nic.in](http://www.dhenkanal.nic.in) and submitted alongwith the above cost in shape of Bank Draft/ Bankers Cheque to be drawn in favour of **District Welfare Officer, Dhenkanal** payable at State Bank of India, Dhenkanal. Separate Tender/ Quotation should be submitted for each item/ material.
2. The tenderer/ quotationer/bidder shall have to deposit EMD amounting to Rs. 25,000/- (Rupees twenty five thousand) only for each item/ material separately in shape of Bank Draft/ Bankers Cheque duly pledged/ drawn in favour of the "District Welfare Officer, Dhenkanal" Payable at S.B.I, Dhenkanal and attach the same in original with the tender/quotation. The EMD so deposited by the unsuccessful tenderers/ quotationers/bidders will be refunded soon after completion of the tender process. The EMD of the successful tenderer/quotationer will be converted to Security Deposit.
3. The Successful tenderer/quotationer/bidder shall have to supply the items/materials within 30 (thirty) days from the date of placement of order at the office of the District Welfare Officer, Dhenkanal. If the tenderer/quotationer/bidder fails to supply the same within the stipulated period, the order will stand cancelled automatically and the security deposit will be forfeited.
4. The rate per piece of Bed Sheet shall be within Rs. 235/- (Rupees two hundred thirty five) only and Stainless Steel Tray within Rs.200/- (Rupees two hundred) only inclusive of all taxes and transportation charges. The item/material to be purchased should confirm to the sample approved by the District Level Purchase Committee. The Purchase Committee is not bound to accept the lowest Quotation and decision of the Purchase Committee shall be final and binding.
5. The size of Bed Sheet shall be 7'0" X 4'0" and Stainless Steel Tray should be 14"X12".
6. The tenderer/quotationer/bidder should bring a maximum of 3 (three) samples of the items/materials for which the rate quoted at the time of opening of tenders/quotations.
7. The approved tenderer/quotationer/bidder shall have to supply the "Stainless Steel Trays" engraved with "Dhenkanal SSD School". The Bed Sheets have to be either embroidered or written with permanent marker at the top and bottom corner " Dhenkanal SSD School". This should also be done on the samples of each item/ material to be examined by Purchase Committee.
8. The sealed quotations/ tenders should accompany with self attested photocopies of the following documents.
  - a) PAN Card
  - b) GSTIN Registration Certificate
  - c) Up to date GST Clearance Certificate
  - d) Original Money Receipt of District Welfare Officer, Dhenkanal towards purchase of Tender Paper.
9. The quotations/tenders received after the stipulated date and time or without required documents, EMD will be outrightly rejected. The authority shall not be responsible for any postal delay.

All other terms & conditions mentioned in the quotation call notice as above stands unaltered.






