
Corrigendum to Tender Call Notice No. 2681/SW, Dt. 21.12.2018, for GP level wall painting.

3. Opening of Tender Paper : 21.01.2018 at 3.00 P.M.





The tender will be opened on dt. 05.01.2019 at 3.30 P.M in the office chamber of Collector, Dhenkanal in the presence of the Purchase Committee constituted for this purpose and the tenderer or their authorized representatives. DETAILED TENDER PAPER FOR GP LEVEL WALL PAINTING IN DHENKANAL DISTRICT.

1. Detailed tender papers can be obtained from the office of the DSWO, Dhenkanal on any working day during office hour from Dt.22.12.2018 to Dt.04.01.2019 up to 5.00P.M on deposit of a non - refundable amount of Rs. 2000/-.(Rupees Two Thousand) only. The sample copies can be seen in the office of the DSWO, Dhenkanal in office hour on any working days till last date and time of submission of tender. The Money Receipt obtained in token of purchase of tender paper in original shall be submitted along with the tender form. The tender without original money receipt will be summarily rejected. The detailed tender paper should be returned with the tender duly signed by the tenderer as token of acceptance of the terms and conditions.
2. The tenders shall be received in the Office of DSWO, Dhenkanal by registered post/ Speed Post/ Courier till 1.00P.M on dt. 05.01.2019 and will be opened on dt. 05.01.2019 at 3.30 P.M in the office Chamber of Collector, Dhenkanal in the presence of the Purchase Committee members and the bidders or their authorized representatives. The tender received beyond the date and time shall not be taken into consideration.

4. The Tender paper should be submitted in sealed cover super scribing in capital letters such as **“TENDER FOR GP LEVEL WALL PAINTING”**.
5. The tender paper should be filled in properly and legibly in plain paper/ letter pad without any correction/ over writing and must be a typed / computer typed copy.
6. The price of painting charges is to be quoted per wall painting.
7. The price quoted must be inclusive of Ink/Colour for painting / all taxes / duties/ transportation cost etc. The rate should be written both in words and figures in the tender. The rate quoted should be final and the tenderer shall not be allowed to change the same under any circumstances. The rate should be within the estimated rate prescribed by Govt. (i.e. Rs.1000.00 per wall painting).
8. The purchase Committee will not be bound to accept the lowest tender. The Committee will verify all the documents and the tender will be finalized taking in to consideration both the rates quoted by the firm and documents submitted by the tenderer. The decision of the purchase Committee regarding selection of the firms will be final.

9. The bidder has to submit the following documents along with the tender paper :
- a. Original Money Receipt of Tender Paper.
 - b. Copy of Registration Certificate.
 - c. Attested copy of PAN Card.
 - d. Attested copy of VAT clearance Certificate for the year 2018-19
 - e. Attested copy of GST Registration Certificate.
 - f. Attested copy of GSTR-3B filled upto June-2018.
 - g. Original tender paper duly signed by the tenderer as token of acceptance of the terms and conditions of the tender.
 - h. Past Experience Certificate if any.
10. The bidder has to give E.M.D of Rs 20,000/-(Rupees Twenty Thousands) only at the time of submission of tender in shape of N.S.C./ Term deposit duly pledged in favour of D.S.W.O, Dhenkanal. No bidder shall be allowed to withdraw his tender/ earnest money until the tender is finalized. The E.M.D of un-successful bidder shall be refunded where as the E.M.D of successful bidder will be converted as Security Deposit.
11. The Collector, Dhenkanal is not liable for payment of any interest on the Security Deposit or any depreciation there of.
12. The Security Deposit will be released after finalization of supply and settlement of Accounts.
13. The decision of the Purchase Committee regarding selection of the printing press will be final.
14. Payment will be made within one month from the date of receipt of bills, subject to availability of funds and no interest will be paid for any delayed payment.
15. a) No advance payment shall be made.
b) Payment will be made only after completing the wall painting at GP Level.
16. Any damaged / illegible/bad quality items detected during scrutiny will not be accepted.
17. In case of any dispute, the orders / decisions of the District Magistrate and Collector, Dhenkanal will be final and binding.
