


1. The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc which are mandatory for plying of vehicle.
2. The Driver of the vehicle must have a valid Driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. A Sum of Rs. 5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the District Social Security Officer, Dhenkanal and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants)
6. The vehicles must achieve a fuel efficiency of 17 Kms per litre.
7. The details of the make and year of manufacture of the vehicle, registration no. mileage(Kms covered per litre) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/ Tender (Annexure- II)
8. The Quotation completed in all respect should reach the undersigned on or before 04.02.2019 by 1.00 P.M and shall be opened on the same day at 3.00 PM in the Office of the District Social Security Officer, Dhenkanal in presence of the bidders or their authorized representatives.

The application form of quotation /tender containing General Bid Information & Terms and conditions for Hiring of Vehicles etc. will be available from the office of the D.S.S.O, Dhenkanal on payment of Rs 500/- from 25.01.2019 to 04.02.2019 till 11.00 A.M or can be downloaded from Website www.dhenkanal.nic.in. In case the application form is downloaded from Govt, website, the applicant shall furnish a Demand Draft for an amount Rs. 500/- (Rupees Five Hundred) only in favour of District Social Security Officer, Dhenkanal towards the cost of application along with the application.


