**TENDER NOTICE**

Sealed Tenders are invited in plain paper for disposal of 01 (one) Diesel Jeep bearing Registration No. **OR-02-5321** (Mahindra Model) of District Information & Public Relations Office, Dhenkanal having offset price fixed at Rs. 21,000/- (Rupees Twenty One thousand) only.

The Tender paper should be submitted by **Registered Post / Speed Post** only which should reach this office latest by 11.00 A.M. on Dt. 05.07.2019 ( 5<sup>th</sup> July, 2019). The word "TENDER PAPER FOR JEEP" shall be written on the envelope containing the tender paper.

The intending tenderers may inspect the vehicle during the office hours on any working day in the Garage attached to the Office of D.I. & P.R.O., Dhenkanal.

The intending tenderers are required to write the tender papers in their own handwriting without any overwriting and sign with their full address.

Each intending tenderer is required to deposit earnest money of **Rs. 1,000/-** (Rupees One thousand) only in shape of Bank draft drawn in favour of "**D.I. & P.R.O., Dhenkanal**" payable at **SBI, Main Branch, Dhenkanal** and shall submit the same along with the tender paper. The un-successful tenderers will get back their earnest money (Bank Draft) on the date of opening of the sealed tenders.

Sealed covers will be opened in the office chamber of the undersigned on **Dt. 05.07.2019 at 12.30 P.M.** The tenderers or their authorized agents shall remain present at the time of opening.

The highest tender shall be accepted. The successful tenderer shall deposit 25% of the offered amount immediately after the sale is confirmed and the rest amount within 7 (seven) days from the date of acceptance of the tender failing which the earnest money along with the deposited 25% of the tendered value shall be forfeited. The 25% of the bid amount and the earnest money deposited are subject to adjustment at the time of final payment of the tendered value.

The vehicle shall not be delivered to confirmed tenderer until he makes full payment of the tendered amount and comply all the formalities. The vehicle tools, instruments and spare parts shall not be delivered with the vehicle.


The vehicle shall be removed from the site within 07 days from the date of depositing the full amount of the tendered money. Custody and safeguard of the vehicle shall be the responsibility of the bidder and no claim or complaint in this regard shall be entertained.

On failure to remove the vehicle within the stipulated time as mentioned above, ground rent @ 1% of the tendered amount shall be charged for each day till removal of the vehicle from the site.

If the ground rent so charged exceeds the sale price deposited, the tenderer shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent and the vehicle shall become the absolute property of Government and disposed of by fresh tender.


The authority reserves the right to reject the highest tender or all tenders without assigning any reasons thereof.


