Terms of Reference Cleaning & Sanitation work of the Regional SARAS Mela 2019

A) Detail Specifications of the works:

- i) **Following works to be done during Regional SARAS Mela 2019 at Dhenkanal from 14th to 23rd October 2019 at Mahishapat Ground, Dhenkanal.**
1. Sweeping and cleaning of Mela Ground, Food Court, Urinal.
 2. Team of sweepers along with one supervisor will be engaged for 2 sift in a day & one sift will be for 8 hours.
 3. Sweeper will always be placed at near the toilets for cleaning it, at regular intervals.
 4. Toilets cleaning with requisite materials like phenyl & bleaching power, naphthalene ball etc have to be provided by the bidder.
 5. Garbage Cleaning : Garbage has to be lifted (Approx. 3 trip per day trough carrier vehicle) from mela ground on daily basis.
 6. Water Sprinkling : Water sprinkling has to be done at the mela ground (Approx. two trips per day @ 4500 ltr. per trip)
- ii) **Terms and Conditions**
1. The work assigned to the firm should be done as per the above specification and should cover all aspects of the exhibition.
 2. The work should be completed within the time frame.
 3. Sanctions of any advance will not be allowed. The payment will be made on completion of the event and submission of proper bills.
 4. The gross approved price would be including GST. The GST-TDS as per law will be deducted from the bill amount and deposited with the concerned authority.
 5. The offered price by the firm shall be including of all taxes and duties. But, the bidder should submit the bill showing the net value (+) Add: the GST as applicable as on date.
 6. The tenderers are required to deposit an earnest money deposit of **Rs. 2,000/- (Rupees two thousand only)** in shape of demand draft/pay order in favour of DSMS, payable at Dhenkanal. The E.M.D. amount of the successful tenderer will be refunded within a month on award of contract subject to receipt of Performance Security. Tender papers without E.M.D shall not be accepted.
 7. The tenderers have to offer the price for all items as per format given else the tender paper will not be considered.
 8. The rate offered by the firm should be valid for 12 months w.e.f. finalization of the tender.
 9. Payment will be made on completion of the event and satisfactory performance of the vender.
