Terms and Conditions :

1. The engagement is purely temporary and terminable at any time without notice and assigning any reason thereof.
2. He shall submit the written Undertaking in the Model Form (Enclosed) prior to his joining in the respective post as per contractual engagement.
3. He/She shall continue on contractual basis for a period of Six years. The period of Six years shall be counted from the date of his joining in the respective post as per contractual engagement.
4. On the date of satisfactory completion of six years of contractual service after joining, he/she shall be considered for regular appointment. On regular appointment he shall be entitled to draw the time scale of pay plus Grade Pay with DA and other allowances as admissible in the corresponding pay band.
5. Subject to satisfactory performance, the consolidated remuneration shall be enhanced as per fitment table (under Stage-4) in accordance with Rule 9(3) of Odisha Group – C and Group-D Posts (Contractual Appointment) Rules, 2013.
6. He/She shall not be entitled to DA, HRA, RCM and other allowances during the period of contractual engagement.
7. He/She shall abide by the Odisha Civil Service Conduct Rules 1959 and O.C.S. (C.C. & A) Rules's 1962.
8. He/She should submit the following documents to the District Social Security Officer, Dhenkanal/ Concerned BDO at the time of his joining in the post failing which the joining report shall not be accepted.
 - a) Medical Fitness Certificate signed by the Govt. Medical Practitioner not below the rank of Asst. Surgeon.
 - b) Two character certificates from two gazetted officers.
 - c) Two Passport size self attested photographs.
 - d) Copies of Certificates in support of her/his qualification and date of birth/resident/caste (self attested)
 - e) Marital declaration, if married, having not more than one spouse living.
 - f) Oath of allegiance to the constitution of India.
9. He/She should report for duty before the District Social Security Officer, Dhenkanal/ Concerned BDOs within 15days from the date of issue of the order failing which the appointment order shall be automatically cancelled.
10. No travelling Allowances is admissible to join in the post.


