ORDER

Whereas, the Government of Odisha in Revenue & Disaster Management (Disaster Management) Department, with a view to contain the spread of COVID- 19, extended the lockdown period in the entire State of Odisha for a further period of two weeks and laid down the certain stipulations/guidelines for strict implementation with effect from 04.05.2020 till the midnight of 17.05.2020.

Whereas, as per the new guidelines, the districts in the State have been divided into Red (Hotspots), Green and Orange Zones.

Whereas, as per the said new guidelines, the district of Dhenkanal comes under orange zone category as per letter No.10546/H/dt.03.05.2020 of H&FW Department.

Now, therefore, it is hereby ordered that -

- 1) **The following activities will continue to remain prohibited throughout the Dhenkanal district for a period of two weeks with effect from 4th May, 2020**
 - i) All passenger movement by trains, except for security purposes or for purposes as permitted by MHA.
 - ii) Inter-State Buses for public transport, except as permitted by MHA.
 - iii) Inter-State movement of individuals except for medical reasons or for activities as permitted by MHA.
 - iv) All schools, colleges, educational/training coaching institutions etc. However, online/distance learning shall be permitted.

- v) Hospitality services other than those used for housing health/ police/ Government officials, healthcare workers, stranded persons including tourists and those used for quarantine facilities.
- vi) All cinema halls, shopping malls, gymnasiums, sports complexes, swimming pools, entertainment place, theatres, bars, auditoriums, assembly halls and similar places.
- vii) All social/ political/ sports/ entertainment/ academic/ cultural/ religious functions/ other gatherings.
- viii) All religious places, places of worship shall be closed for public. Religious congregations are strictly also prohibited.
- ix) Inter-district and Intra-district bus movement.
- x) All kinds of liquor shops in the district.
- xi) All hotels, restaurant, tea stall, betel shop, salon, beauty parlour, sarbat, lassi, fruit juice, Jewelry shop, all categories of temporary/movable food stall/shop.

2) **Allowed activities in the District of Dhenkanal :**

- i) All other activities, including operation of all kinds of shops and commercial and industrial establishments, (except those activities that are prohibited **under Para-1**) will be permitted during the extended lockdown period, on the condition of social distancing and wearing of masks.
- ii) All construction and developmental works shall be permitted.
- iii) All shops, markets and commercial establishments, grocery shops, milk booth shall be allowed to remain open only from **7 am to 2 pm**.
- iv) For medicine shops, there shall be no time restriction.
- v) All shop owners shall ensure social distancing in and outside their shops. Any deviation in this regard will lead to closure of the particular shop.
- vi) Taxis, Cab aggregator and Auto with one driver and two passengers only.
- vii) Inter-district movements of individuals and vehicles, only for permitted activities. Four wheeler vehicles will have maximum two passengers besides the driver. For two wheelers pillion rider is not allowed.

3) **Measures for well being and safety of persons in the district of Dhenkanal :**

- i) The movement of individuals, for all non-essential activities, shall remain strictly prohibited **between 7 pm to 7 am**. Any person moving around between 7 pm and 7 am for non-essential purposes shall be penalized under section-188 of Indian Penal Code.
- ii) Persons above 65 years of age, persons with co-morbidities, pregnant women, and children below the age of 10 years, shall stay at home, except for meeting essential requirements and for health purposes, as per the National Directives.


This order will come into force with effect from 04.05.2020.
