The tender paper should reach before the undersigned on or before dt 04-07-2020 at 01.00 PM in the prescribed format. The tender papers will be opened at 03.00 PM on the same day in the Office chamber of Project Director, DRDA, Dhenkanal in presence of the suppliers or their authorized agents.

TERMS AND CONDITIONS

- 1 The firms / suppliers should furnish GST clearance Certificate approved dealership certificate if any along with quotation.
- 2 The suppliers or authorized agent should show their sample of the tile before the committee at the time of opening of tender.
- 3 The suppliers may visit DRDA, Dhenkanal on any working day (RH Section) and inspect the sample of tile with Logo before drop their tender papers.
- 4 The size of the tile logo is (15x15) inches.
- 5 The district committee forms for the purpose reserves the right to reject any or all tender paper without assigning any reason thereof.
- 6 The suppliers so selected will supply the logo to the respective block directly as per the requisition of the authority.
- 7 The no of Logo required each year will be as per allotment of PMAY (G) target to the district.
- 8 Selection of agencies / suppliers will not make it blinding on the part of DRDA / blocks to purchase the engraved Logo in specified quantity in specific time interval. It is directly as per requirement on completion on PMAY (G) houses in the district.
- 9 The firms/ suppliers should quoted the price in their firms / suppliers paper.
- 10 Any deviation on the aforesaid conditions will lead to cancellation of the quotations.

- 11 The quotationers should deposit non refundable amount of Rs2000/- (Rupees two thousand) only in shape of demand draft favour of Project Director, DRDA, Dhenkanal payable at State bank of India, Dhenkanal main branch towards cost of the the tender paper.
- 12 The agreement for supply of BPGY tile logo will be valid till 31-3-2021 .
