ORDER

Whereas the signatory of this order has been empowered U/s-2(1) of Epidemic Disease Act, 1897 read with Clause II of Covid-19 Regulations- 2020 framed by Government of Odisha to take effective measures for containment of the epidemic which has already been declared as a pandemic;

Whereas, the District Disaster Management Authority has the power to take necessary measures U/s 30 to 34 of Disaster Management Act, 2005 to prevent the spread of this disaster;

Whereas, the objective of the administration is to go for immediate social distancing, enhanced active surveillance, ensure testing of all suspected cases as per need;

And whereas, **three (03) nos of positive cases of COVID-19** has been detected on dt. **26.07.2020** from the staff of **the office of the Panchayat Samiti, Gondia** .

And whereas, it is felt necessary to contain any further possible spread of COVID-19 and perspective of public interest.

Now therefore, in exercise of powers conferred under Disaster Management Act, 2005 & Epidemic Disease Act, 1897 read with Clause -2 of COVID-19 Regulations- 2020, **I Sri Bhumesh Chandra Behera, OAS (SAG), Collector & DM, Dhenkanal do hereby declare the campus and premises of office of the Panchayat Samiti, Gondia as Containment Zones for 72 hours i.e from 7 AM of 27.07.2020 to 7 AM of 30.07.2020.** The restrictions applicable to containment zones as per guidelines of H&FW Department shall be implemented & it will be enforced/ monitored under the direct supervision of the Sub-Collector & Empowered Officer, Dhenkanal

This order will come into force with immediate effect.
