**ORDER**

Whereas the signatory of this order has been empowered U/s-2(1) of Epidemic Disease Act, 1897 read with Clause II of Covid-19 Regulations- 2020 framed by Government of Odisha to take effective measures for containment of the epidemic which has already been declared as a pandemic;

Whereas, the District Disaster Management Authority has the power to take necessary measures U/s 30 to 34 of Disaster Management Act, 2005 to prevent the spread of this disaster;

Whereas, the objective of the administration is to go for immediate social distancing, enhanced active surveillance, ensure testing of all suspected cases as per need;

And whereas, one positive case of Covid-19 has been detected in office of the **Deputy Registrar of CO- operative Society, Dhenkanal on 17.08.2020.**

And whereas, it is felt necessary to contain any further possible spread of COVID-19 in office and community:

Now therefore, in exercise of powers conferred under Disaster Management Act, 2005 and the Epidemic Disease Act. 1897 & Regulation-2020, **I Sri Bhumesh Chandra Behera, OAS (SAG), Collector & DM, Dhenkanal do hereby order to shut down the office of DRCS, Dhenkanal, ARCS, Dhenkanal and AAGCS, Dhenkanal from 18.08.2020 to 21.08.2020.** The restrictions applicable as per guidelines of H&FW Department and GA & PG Department shall be implemented & it will be enforced/ monitored under the direct supervision of the Sub-Collector & Empowered Officer, Dhenkanal. The sanitization and disinfection of the campus and premises of the said office buildings shall be done immediately by the Executive Officer, Dhenkanal Municipality.

**Contact Tracing**

There shall be intensive contact tracing. Contacts of the confirmed and suspected cases will be line listed, tracked and kept under surveillance. All confirmed and suspected cases shall be tested accordingly by medical team.

The CDM & PHO, Dhenkanal, will mobilize required health staff immediately to conduct contact tracing, surveillance and testing.

All employees of above offices having close contact with the positive cases shall remain home quarantine at headquarter from 18.08.2020 to till received of the negative report and make available to accomplish official works from home.

This order will come into force with immediate effect and shall remain enforced until **21.08.2020**.
