ORDER

Whereas the signatory of this order has been empowered U/s-2(1) of Epidemic Disease Act, 1897 read with Clause II of Covid-19 Regulations- 2020 framed by Government of Odisha to take effective measures for containment of the epidemic which has already been declared as a pandemic;

Whereas, the District Disaster Management Authority has the power to take necessary measures U/s 30 to 34 of Disaster Management Act, 2005 to prevent the spread of this disaster;

Whereas, the objective of the administration is to go for immediate social distancing, enhanced active surveillance, ensure testing of all suspected cases as per need;

And whereas, **1 (One) positive case of COVID-19** has been detected from **Khajuria Village under Mukutapasi GP of Kankadahad Block, Dhenkanal on dt. 31.08.2020.**

Whereas, it is felt necessary to contain any further possible spread of COVID-19 and perspective of public interest and for the sake of speedy completion of active surveillance in the containment zone.

Now therefore, in exercise of powers conferred under Disaster Management Act, 2005 & Epidemic Disease Act, 1897 read with Clause -2 of COVID-19 Regulations- 2020, **I Sri Bhumesh Chandra Behera, OAS (SAG), Collector & DM, Dhenkanal do hereby declare the Khajuria Village under Mukutapasi GP of Kankadahad Block, Dhenkanal as Containment Zone for the period of 72 hours i.e. from 7 A.M of 01.09.2020 to 7 A.M of 04.09.2020.**

The restrictions applicable to containment zones as per guidelines of H&FW Department shall be implemented & it will be enforced/ monitored under the direct supervision of the Sub-Collector & Empowered Officer, **Kamakhynagar**. It is decided not to declare buffer zone adjoining to containment zone. The boundary of Containment Zone as follows.

Boundary point of containment Zone

Bramha Sahoo's House ⇒ Ranjan Nayak's house connecting Makara Shop ⇒
Ramakanta Sahoo's house.

The vehicular movement in totality both in public and private is stopped in the containment zone excluding the vehicles permitted for supply of essential items, medicines, medical emergency, health surveillance, sanitization and other necessary activities to be undertaken by District Administration/ Block Administration, **Kankadahad**. All the shops and business establishments irrespective of the scale and size in Containment zone will be closed with immediate effect. The supply chain of medicine and other essential items will be kept uninterrupted by the BDO, **Kankadahad**.

All inhabitants of the Containment zones will stay in-door and this is to be followed without deviation. Violation will invite strict penal action as per Disaster Management Act-2005 and Epidemic Disease Act, 1897 & Covid-19 Regulations- 2020. The following officers will act as Nodal Officers to ensure smooth supply of essentials, sanitization, active survey & surveillance, law and order & others in the Containment Zone.

9. Marketing Inspector, BDO, **Kankadahad** - Supply of Essential Commodities.
10. Station Fire Officer, **Kankadahad** - Maintenance of sanitation and sanitization of areas in buffer zone.
11. Tahasildar-Cum-Incident Commander, **Kankadahad** - Maintenance of Law & Order, enforcement and implementation of all activities relating to Containment.
12. BDO, **Kankadahad** - Over all co-ordination
13. CDM&PHO Dhenkanal/ Medical Officer I/C, **Kankadahad** - Health/Medical arrangements.
14. Sub-Divisional Police Officer, **Kankadahad** /IIC, **Kankadahad** PS, shall make necessary arrangement for immediate deployment of adequate police at the points of requirement and to be supervised accordingly.
15. CDM&PHO, Dhenkanal/ Block Medical Officer I/C, **Kankadahad** - Active House to House Survey & Surveillance.
16. Overall Supervision & Monitoring- Sub-Collector, **Kamakhyanagar**.

Contact Tracing

There shall be intensive contact tracing in Containment zones. Contacts of the confirmed and suspected cases will be line listed, tracked and kept under surveillance at home for 14 days.

Surveillance

The area of Containment zones will be under active surveillance. The CDM&PHO, Dhenkanal/ Block Medical Officer I/C, **Kankadahad**, will mobilize required health staff immediately to conduct surveillance in Containment zones. Supervisory Officers will be also named by the CDM&PHO, Dhenkanal. The active surveillance will start from **01.09.2020** and completed by **04.09.2020**.

The CDM&PHO, Dhenkanal/ Block Medical Officer I/C, **Kankadahad**, shall provide required numbers of masks, hand gloves, head covers to all surveillance team members & supervisors for conducting Active Surveillance in Containment zones and train them accordingly. The aforesaid process must be followed as per the guidelines of H&FW, Deptt. Govt. of Odisha & same must be ensured by CDM&PHO, Dhenkanal. All ILI and SARI cases either reported in the last 14 days by the IDSP or ascertained in course of Active Surveillance exercise will be tracked and reviewed thoroughly in Containment zones. Swab will be collected from all cases of confirmed contact history/Symptoms at the earliest for testing at the designated Labs.

This order will come into force with immediate effect without any dilution and shall remain enforced until **04.09.2020**.
