**ORDER**

Whereas the signatory of this order has been empowered U/s-2(1) of Epidemic Disease Act, 1897 read with Clause II of Covid-19 Regulations-2020 framed by Government of Odisha to take effective measures for containment of the epidemic which has already been declared as a pandemic;

Whereas, the District Disaster Management Authority has the power to take necessary measures U/s 30 to 34 of Disaster Management Act, 2005 to prevent the spread of this disaster;

Whereas, the objective of the administration is to go for immediate social distancing, enhanced active surveillance, ensure testing of all suspected cases as per need;

Whereas, 1 (One) positive case of COVID-19 has been detected from **UCO, Bank, Dhenkanal Branch, Dhenkanal** on **05.09.2020**;

And whereas, it is felt necessary to contain any further possible spread of COVID-19 in the office community:

Now therefore, in exercise of powers conferred under Disaster Management Act, 2005 & Epidemic Disease Act, 1897 & Regulation- 2020, **I Sri Bhumesh Chandra Behera, OAS (SAG), Collector & DM, Dhenkanal** do hereby declare the premises of **UCO, Bank, Dhenkanal Branch, Dhenkanal** as containment zone for the period of **72 hours i.e. from 7 A.M. of 07.09.2020 to 7 A.M. of 10.09.2020**. The restrictions applicable as per guidelines of H&FW Department & GA & PG Department shall be implemented & it will be enforced/ monitored under the direct supervision of the Sub-Collector & Empowered Officer, **Dhenkanal**. The Sanitization and disinfection of the campus and premises of the said buildings shall be done immediately by the **E.O. Municipality, Dhenkanal**.

### Contact Tracing

There shall be intensive contact tracing. Contacts of the confirmed and suspected cases will be line listed, tracked and kept under surveillance. All confirmed and suspected cases shall be tested accordingly by medical team.

The CDMO and PHO, Dhenkanal, will mobilize required health staff immediately to conduct contact tracing, surveillance and testing.

All employees of the above Bank having close contact with the positive cases shall be remain home quarantine at headquarter from **05.09.2020** to till received of the negative report and make available to accomplish official works from home.

This order will come into force with immediate effect without any dilution and shall remain enforced until **10.09.2020**.
