
1. The vehicle must be in road worthy condition & shall not be more than 3 years old from the date of initial registration and must have valid Registration certificate, Insurance certificate, Fitness certificate, valid Contract Carriage permit, proof of up to date Tax payment etc., which are mandatory for plying of vehicle.
2. The driver of vehicle must have a valid driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport vehicle.
3. The driver should be well behaved, gentle & obedient in nature.
4. A sum of **Rs. 5000.00** shall be deposited by intending bidders in shape of account payee Bank Draft drawn in favour of the CSO-cum-District Manager, OSCSCLtd., Dhenkanal and submit along with tender as security deposit. After completion of tender process the amount will be refundable to unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in the general bid information (excluding Fuel and lubricants).
6. The vehicle must achieve a fuel efficiency of 10 kms per liter.
7. The details of the make and year of manufacture of the vehicle, registration no, milage (kms covered per litre) and name of the driver with Driving licence No. and period of validity should be specifically provided in the general bid information to be furnished with the Tender (Annexure -III).

8. The tender completed in all respect should reach the undersigned on or before **21.09.2020 by 2.30 PM** through **Regd. Post/Speed Post/Courior Service** only. **The Technical Bid shall be opened on Dt.21.09.2020 at 4.00 PM and the Price Bid shall be opened on the same day at 5.00 PM** in presence of the bidders or their authorized representatives.




