INVITATIONS FOR BIDS THROUGH e-Procurement

1. The Sub-Collector, Hindol-Cum-Chairman, R.M.C Hindol - invites **percentage rate bids in SINGLE COVER (TECHNICAL BID & PRICE BID) in online mode** for the work in the table below from **the eligible contractors having experience in similar nature of work** registered as given in column "06" with Govt. of Odisha or equivalent class of Govt. of India / C.P.W.D. /Central Undertaking / Railway / M.E.S along with the proof of registration from the Appropriate Authority shall be enclosed along with the Bid. If successful, the Bidder who has not been registered under State Government has to register under the Appropriate Authority of the State Government of Odisha in appropriate class of eligibility before award of the work as per prevalent registration norm of the State.
2. The bidders may submit bids for the following works.

3. Bid documents consisting of Specification, Schedule of Quantities, and a set of Term & conditions of contract and other necessary documents can be seen in the **e-procurement portal, www.tendersodisha.gov.in** .
4. The tender paper cost and EMD/ Bid securities of the amounts specified for the work in column 5 & 6 above, The bidder shall make electronic payment using his or her internet banking enabled account with designated bank or their aggregator bank such as SBI/ICICI/HDFC or the bidder having account in other banks can make payment using NEFT / RTGS facilities of designated banks . Bidder desirous to hire machinery or equipment for outside the state or owned but deployed outside the state are required to furnish 2 % of the amount put to tender as bid securities.
5. The bid documents will be available in the web site **www.tendersodisha.gov.in** from **11.00** hours of **28.09.2020** to **17.00** hours of **12.10.2020** for **on line bidding**.
6. The bidder must possess compatible Digital Signature Certificate [DSC] of appropriate class.
7. Bid shall be received only ' Online' on or before-**12.10.2020** up to 17.00 hours.
8. Bids received online shall be **opened** at 11.00 hours on **13.10.2020** in the office of the Regulated Market Committee, Hindol in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after login on to the site through their D.S.C. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working days.
9. The cost of bid document and EMD as mentioned in column 5 & 6, The bidder shall make electronic payment using his or her internet banking enabled account with designated bank or their aggregator bank such as SBI/ICICI/HDFC or the bidder having account in other banks can make payment using NEFT / RTGS facilities of designated banks.
10. After opening of financial bid, the original documents of successful lowest bidder as per requirement of Detailed Tender Call Notice [DTCN] will be verified in the office of the undersigned within 5 (five) working days of opening of bid.
11. Other details can be seen in the Detailed Tender Call Notice [DTCN].Other details can be seen in the bidding documents.
12. The authority will not be responsible for any technical snag or network failure during on-line bidding.
13. Engineering contractors who are desirous to avail the facility of exemption of EMD are required to submit an affidavit along with bid document to the effect that he/she had not yet availed the facility during current financial year as per codal provisions and they are also required to produce their original registration license at the time of opening of the bid for necessary entry, failing which his/her tender(s) will not be entertained and thus liable for rejection.
14. The SC/ST contractors willing to avail the facilities as fixed by Govt. will submit an affidavit for the same along with tender document; otherwise they will not be entitled to avail such facilities. Claim at the time of opening of tender or later will not be entertained.



15. The original affidavit regarding authentication of the documents and all other document in original shall be furnished before the TEC at the time of opening of tender for verification.
16. The bidders shall have to produce an affidavit in support of authenticity of documents / credentials. Other details can be seen in the bid documents available in above website.
17. The authority reserves the right to reject any or all tenders without assigning any reason thereof.


