ORDER

The Government of Odisha vide its Order No-7384/R&DM (DM)/dt.30.12.2020 have ordered to reopen more activities in areas outside containment zones up to 31.01.2021 wherein District Collector has been authorized to accord permission for public worship in religious places/places of worship with appropriate restriction, based on local assessment of the situation with regards to COVID-19 and in due consultation with relevant stake holders, with observance of COVID-19 safety protocol.

Accordingly, assessment of ground level situations have been made and in due consultation with relevant stake holders, it is hereby ordered that, the following temples of the district shall be opened for Sevayat families on dt.03.01.2021 (one day only) and from 04.01.2021 to 14.01.2021 for General public/devotes of Dhenkanal district and for General public/devotes of other districts from 15.01.2021 to onwards with strict adherence of guidelines enclosed herewith.

Further, all Mosques shall be opened on every Friday from 04.01.2021 for common prayer purposes with maximum ceiling of 20 persons and all Churches shall be opened on every Sunday from 04.01.2021 onwards for common prayer purposes with maximum ceiling of 20 persons following all containment guidelines of COVID-19 & SOP of opening of religious institutions.
