
Sub: Public Hearing proposed by the Tahasildar, Parjang for Brahmani River Sand Quarry, Panigengutia over an area of 5.66 Ha. at Panigengutia, Parjang Tahasil of Dhenkanal District-regarding.

Public Hearing for Brahmani River Sand Quarry, Panigengutia for exploitation of River sand production of 13000 cum/year over an area of 5.66 ha. at Parjang Tahasil was fixed to **04.05.2021 at 11.00 A.M. at Community Center of Panigengutia village** in Dhenkanal District vide District Office Letter No. 2832/Touzi/Dt.22.03.2021.

And whereas, as per the Notification No.6412/IND-II-MISC-02/Dt.18.04.2021 of State Pollution Control Board, Odisha, Bhubaneswar, Govt. has put restrictions on public gathering vide Office of Special Relief Commissioner, Govt. of Odisha Order No.1968/R&DM, dated.15.04.2021 due to sudden upsurge of Covid infection in the State and this restriction on public hearing may continue for a longer period. Conducting public hearing of proposals as scheduled above may further increase in Covid infection at the public hearing venue and surrounding area.


And whereas, State Pollution Control Board has cancelled the public hearings of all the proposals as scheduled until further order.
