Whereas, the District Disaster Management Authority has the power to take necessary measures U/s 30 to 34 of Disaster Management Act, 2005 to prevent the spread of this disease;

Whereas, the objective of the administration is to go for immediate social distancing, enhanced active surveillance, ensure testing of all suspected cases as per need;

Whereas, 05 (Five) positive cases of COVID-19 has been detected in Civil Court Premises, Dhenkanal on 16.05.2021 and many other staffs displaying flue like symptoms, in larger public interest and with a view to contain the further spread of virus;

Now therefore, in exercise of powers conferred under Disaster Management Act, 2005 & Epidemic Disease Act, 1897 read with Clause -2 of COVID-19 Regulations-2020 and in pursuance of order No.2328/ R&DM(DM)/ dt.01.05.2021 of Chief Secretary, Odisha I Sri Bhumesh Chandra Behera, OAS(SAG), Collector & District Magistrate, Dhenkanal do hereby seal the premises of Civil Court, Dhenkanal for a period of 07 days from 7. AM of 17.05.2021 to 7 P.M of 23.05.2021 with the following conditions:

- 1. The premises of Civil Court, Dhenkanal shall be sanitized immediately by **the E.O, Dhenkanal Municipality** in strict adherence to the guidelines issued by Govt. of Odisha and Govt. of India.
- 2. No one shall be allowed to move into or from outside the premises of Civil Court Premises, Dhenkanal during the period of sealing, except authorized personnel of Dhenkanal Municipality.
- 3. The persons detected positive are directed to remain in Isolation at their respective residences. Further, if any positive persons needs Medical attention, the Civil Court Authority is to intimate the same to CDM & PHO, Dkl immediately.
- 4. The Civil Court Authority, Dhenkanal is to intimate **CDM & PHO**, **Dhenkanal/E.O**, **Dhenkanal Municipality** in case of symptoms observed in Staff, other than those already detected positive for their testing and isolation, if found positive.

5. Further specific instructions/orders will be issued as and when required by the undersigned.
