Sealed quotation in plain paper, superscripted "Tender for Disposal of Vehicle" are invited by the undersigned from intending bidders for disposal of Mahindra Jeep bearing Regd No-OR-06-9948 of ICDS, Project Parjang which was purchased during the year 1994, will be held on 04-12-2021 at 11.00AM at Office of CDPO, ICDS Project Parjang with the following terms and conditions.

1. The auction sale will be conducted by the CDPO, Parjang. The intending bidders/ competitors shall deposit a sum of Rs. 1,000/- (Rupees one thousand only) each as security/ earnest money in terms of cash with the CDPO, Parjang before taking part in the auction sale on proper receipt. The same will be refunded to the unsuccessful bidders/ competitors just after the auction sale is over. The successful bidder/ competitors may adjust the said amount towards payment of auction purchased final amount.
2. The highest bidders/ competitors shall have to deposit not less than 25% of the total bid amount immediately after the announcement being conformed by the competent Authority and the balance amount of 75% within 7 (seven) days from the date of auction sale. In case the highest bidder/ competitor fails to make full payment of the bid amount within the time limit specified above, the deposits including the security/ earnest money shall be forfeited and the Vehicle will be put to fresh auction.

5. On failure to remove the vehicle within the above period, ground rent as per rule shall be charged till removal of the vehicle from the site as stated above.
