4. The receipt of the bid documents shall start **from 10.00 AM on Dt. 08.12.2021 to Dt. 22.12.2021 till 04.00 PM only through Registered Post/ Speed Post/ Courier Service addressed to The Project Director, D.R.D.A., Dhenkanal, At/P.O. – Mahisapat, Dist. - Dhenkanal, Odisha, PIN – 759013.**

5. The bids will be opened on **Dt. 23.12.2021 at 11.00 AM (Technical Bid) & at 04.00 PM (Financial Bid)** in the office of the under signed in the presence of the bidders who wish to attend. If the office happens to be closed on the last date of sale and receipt of the bids as specified, the bids will be sold and received on the next working day at the same time and venue and opening of the bids accordingly extended. Similarly, if the office happens to be closed on the date of opening the bids will be opened on the next working day at the same time and venue.
6. Sealed Bids should be accompanied with the attested true copies of the valid registration certificate, GSTIN and PAN card which are mandatory and the original certificate are to be produced within three working days of opening of the tender before P.D. DRDA, Dhenkanal for verification otherwise his / her bids shall be declared as non-responsive and thus liable for rejection. Also, the tenderer should satisfy the eligibility criteria, provided in the relevant clauses of the bid documents (DTCN)
7. Bidder can submit one tender paper for a particular work. Submission of more than one tender paper by a bidder for a particular tender will be liable for rejection of all such tender papers.
8. The bidder shall have to furnish a **"BID Security declaration"** as per the Office Memorandum No.8943 dtd.18.03.2021 of Finance Department, Government of Odisha in lieu of Bid Security in the format annexed Form of Bid Security Declaration along with the bid.

10. The enclosures other than the D.T.C.N. should be page numbered and signed by the contractor.
11. Total No. of enclosures should be submitted by him / her in Numbers and words as per relevant clause of D.T.C.N.
