2. The bidders can also indicate any superior technical specifications.
3. The bidders should display the demo of the materials before the Tender Committee at the time of opening of Tender Papers.

The Bidder must satisfy all the following Eligibility Criteria to participate in this Tender;

1. **General Instructions (Necessary support documents are to be enclosed):**

- A. The tender process will be of two bid system-Technical Bid and Financial bid process. The tenderer should submit two separate sealed cover mentioning Technical Bid & Financial Bid. The tenderer which qualifies in Technical Bid will be eligible to participate in Financial Bid.
- B. The Bid Must Contain the Requisite Tender Document Cost Rs.100/- and EMD of Rs.5000/-as per the advised mode in the technical tender document. The bid documents can be download from the website [www.dhenkanal.nic](http://www.dhenkanal.nic) or can be obtained from the office of the undersign on payment of requisite fee. EMD should be in shape of Demand Draft issued by a nationalized or scheduled bank in favour of "The Divisional Forest Officer, Dhenkanal Division, "Payable at Dhenkanal.
