

SHORT TENDER NOTICE FOR COLLECTION OF CASHEW NUTS AND APPLES  
OF STATE GOSADAN BABANDHA FOR THE YEAR 2021-22

Consequent upon cancellation of tender due to some technical disorder in submitting sealed tender papers by the tenderers, the Chief District Veterinary Officer, Dhenkanal invites Sealed tenders in plain paper from the intending persons/ institutions for collecting Cashew nuts and Apples from the cashew plantation field at Go-sadan, Babandha in Dhenkanal District for the year 2021-22. The last date for receipt of sealed tender is dated 22.3.22 up to 01.00 PM & the same will be opened on at 03.00PM on the same day in presence of the tender committee and the tenders or their authorized representative . The tender papers should be submitted through Courier Service or by Register post or by hand . An amount equal to 20% of the quoted value should be deposited along with the tender papers in shape of bank draft infavour of the undersigned payable at SBI, Dhenkanal towards earnest money. The tenderers are required to furnish Sale-Tax, Income Tax Clearance certificate from the competent authority. The sealed cover containing the quotation with other document should be mentioned in capital letter "TENDER FOR COLLECTION OF CASHEW NUTS AND APPLES 2021-22" should be addressed to the CDVO, Dhenkanal.

On acceptance of highest Tender, the tenders/ institutions, earnest money so deposited will be converted towards security deposit of the quoted value and 50% of the tender value should be deposited on the same day by the tenderer and the balance 50% amount including all taxes as admissible should be deposited within seven days after which the approval order will be issued failing which the cashew field will not be handed over and the tenderer will have no right to collect nuts and apples from the field and the earnest money so deposited will be forfeited. The department will not be held responsible for any natural calamity what so ever. The authority reserves the right to cancel the tender without assigning any reason thereof.
