“Mo Block Mo Dhenkanal ” review meeting of Block was held on Dt.11/05/2022 at Block Conference Hall, Gondia & the BDO / Tahasildar / BEO / BVO / BAO / AAO / AHO / Medical Officer / CDPO / AE / J.Es / / MI / WEO / BSSO & other line Department Officers of Department attended the meeting & the following discussions were made:

At the outset ADM, Dhenkanal welcomed the officers & discussed about the aims of holding such meeting once every month. He impressed upon the members to visit remote & vulnerable areas under this Block & apprise common people about different programme & Scheme of Govt. so as to know their problems & take action to address their problems through open discussion.

Beneficiaries who are more than 90yrs old or infirm fall into such categories.SBI will provide services at their doorstep every month. SBI & other lead banks in the district to ensure that CSPs/BCs remain present in GP Hqrs on the date of disbursement of pension


