Observation Report of SriSaphalya Mandit Pradhan, Project Director, DRDA, Dhenkanal Supervising Officer on review of MIS Mo Bhuban Mo Dhenkanal (MBMD) of Bhuban Block of Dhenkanal District:

The MIS Review meeting of Bhuban Block was held on 11.05.2022 at Conference hall Panchayat Samiti Bhuban. The BDO/ Tahasildar / Medical Officer / CDPO /AEE /J.E/ GPTS/ MI & other line Department Officers of all line Department attended the meeting & the following discussions were made:

At the outset the PD, DRDA, Dhenkanal welcomed the officers & discussed about the aims of holding such meeting once every month. He impressed upon the members to visit remote & vulnerable areas under this Block & apprise common people about different programme & Schemes of Govt. & to know their problems, take action & address their problems through open discussion.

The Governments mandate is to adhere to the 5T programme i.e. **Technology, Team work, Transparency and Time limit leading to Transformation** for officers implementing its program & Schemes. PD, DRDA, DKL expressed his displeasure for this and instructed to JEs and AE to complete drinking water supply out of 15th CFC and to construct toilet out of SBM Scheme-2022-23. 13 nos. Of AWCs of Ekatali GP are not supplied with drinking water due to non-connection of electricity. PD, DRDA, DKL instructed that the concerned GP should initiate steps for connection of electricity and ICDS will pay monthly electricity dues. PD, DRDA, DKL instructed to the JEs/AE that incentive grant received from Govt. for beautification and maintenance should be expended at an early date. The construction work of 31 nos. Of AWCs of Bhuban NAC is not started yet due to site selection. PD, DRDA, DKL instructed to Tahasildar, Bhuban that the site selection work should be completed within seven days by taking their Ris.

Remarks & Feed Back.

- On review of MGNREGS activities it is seen that the PD Generation against the given target is lowest in the District. BDO, Bhuban was directed to undertake more activities to increase the PD Generation. Similarly, the Aadhaar Seedling, ABPS conversion & Geo-tagging of assets figure should be increased as the Govt. has given direction to achieve 100% Aadhaar Seedling, ABPS conversion by end of May – 2022. AEE Bhuban and all JEs were directed to complete the ongoing works as soon as possible.
- BDO, Bhuban was directed to expedite up the pace of House completion and ensure movement of Below Plinth Level houses to their corresponding level immediately. Further, he was instructed to release the instalments in due time and release the incentive amounts to the eligible beneficiaries without fail.
- BDO, Bhuban was instructed to complete all the schools taken under 5T transformation in all respect as the deadline for dedication is 3rd June, 2022.

- Enforcement made by Block team under PDs is very poor. Hence, BDO, Bhuban was instructed to expedite the matter.
- BDO, Bhuban was instructed to complete all the under construction AWCs immediately and handover the same to DSWO as soon as possible.
- Further, BDO, Bhuban was instructed to ensure construction of toilet and provision of drinking water facility to each AWCs.
