04. The sealed Quotation papers will be opened in the office chamber of Additional District Magistrate, Dhenkanal on 07/09/2022 at 11.00 am/~~pm~~. The Quotationers or their authorized agents shall remain present at the time of opening.
05. The bidder quoted the highest price for each items will be regarded as the successful bidder and he will have to deposit the bidding amount in shape of Bank Draft/ Demand Draft / Cash at Nizarat Section, Collectorate, Dhenkanal on the same day.
06. The Successful bidders will be responsible for lifting all the articles with 7 working days from receipt of the order. On failure to remove the articles within the stipulated time as mentioned above, ground rent @1% of the Quotationed amount shall be charged for each day till removal of the article from the premises of Collectorate, Dhenkanal.
07. Quotations will only be accepted in the prescribed format as per annexure-A.
08. In case of failure of deposit of the bid amount by the successful bidder the bid will be cancelled and the earnest money will be forfeited.

The address given in the Quotation shall deemed to be the Purchaser's address and correspondence sent to that address in connection with above context shall be considered to have been delivered to the purchaser. No claim will be entertained for the reason of forfeiture of the sum deposited in case the correspondence is returned back undelivered.




