ACCEEDINGS OF THE PUBLIC HEARING MEETING CONDUCTED ON 26.08.2022 AT 11.00 AM AT JOGAMAYA CRICKET PLAY GROUND, MAUZA- ADIPURA UNDER BHUBAN TAHASIL IN DHENKANAL DISTRICT IN RESPECT OF ENVIRONMENTAL ASSESSMENT FOR MARTHAPUR RIVER SAND QUARRY OVER AN AREA OF 5.058 HA. IN VILLAGE MARTHAPUR UNDER BHUBAN TAHASIL OF DHENKANAL DISTRICT.

Public hearing in respect of Environmental Assessment of Project Marthapur Sand Quarry over an area of 5.058 Ha. in village Marthapur under Bhuban Tahasil of Dhenkanal District.

With reference to:

Sri Udaya Kumar Mohapatra, Additional District Magistrate (Revenue), Dhenkanal District, supervised and presided over the meeting, assisted by Dr. Anup Kumar Mallick, Regional officer, State Pollution Control Board, Angul and the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset Dr. Anup Kumar Mallick, Regional Officer, SPC Board, Angul welcome the other panel member and the public, gave an introduction about the guidelines to be followed for the public hearing in the light of EIA Notifications 2006 in respect of Environmental Assessment of Project Marthapur Sand Quarry over an area of 5.058 Ha. in village Marthapur under Bhuban Tahasil of Dhenkanal District.

Sri Susanta Kumar Sahoo, Consultant and on behalf of Lessee of Marthapur Sand Quarry of Dhenkanal District and on behalf of the proponent addressed the committee members and assembled public and gave a brief description about the proposed project. He also briefed about Marthapur River Sand Bed over an area of 5.058 Ha. in village Marthapur under Bhuban Tahasil of Dhenkanal District with the peripheral

development work that had been taken up in this area, and made a presentation about the environmental management, pollution control measures, solid waste-management of the related project. The copy of the statement of the industry read out at public hearing proceedings is enclosed.

Regarding public hearing of Marthapur sand quarry over ML area of 5.058 Ha. At Village Marthapur under Bhuban Tahasil of Dhenkanal District was publicized at one English Daily newspaper and one Odia daily newspaper before one month. It was also publicized at the office notice Board of Bhuban Gram Panchayat office, Tahasil Office Bhuban, Zilla Parisad Member, Bhuban, Block Chairman Office, Bhuban and local villages of Bhuban, Marthapur and Adipura etc. Public hearing also publicized through loud speaker at the Marthapur village area.

Dr. Anup Kumar Mallick, Regional Officer, State Pollution Control Board, Regional Office, Angul& representative of State Pollution Control Board Odisha then invited the public to present their views about the proposed project on environmental consideration.

The views expressed by various speakers are as follows:

#### 01 Sri Abhimanyu Mishra, Marthapur village

He mentioned that the approach road which is passing through Marthapur village and finally meets National Highway. Adjacent to this road Saraswati Sishu Mandir School is functioning. Earlier sand loaded trucks were passing through this road without covering the trucks by Tarpaulin causing dust pollution in Marthapur village. This single road is being used by villagers, school children and movement of sand loaded and unloaded trucks. He mentioned that Marthapur villagers are completely using this single road and during plying of vehicles on this road causes dust pollution and water pollution. So, he urged that while plying of sand loaded vehicles through this village road, they should adopt tarpaulin covering of vehicle, speed restriction while movement of School children during School timing, proper dust suppression measures by water sprinkling. The lessee should maintain village roads. He expressed that the

proposed sand mining project will lead to development in the area and also for locals.

#### 02 Sri Premananda Mishra, Marthapur village

He mentioned that sand loaded trucks are moving through this village road from 9.30 AM to 10.00 PM. School Children from Class-I to Class- X are also using this road during morning School time and during 4.00 PM. Entire Marthapur villagers are completely using this single road and during plying of sand loaded vehicles on this road causes dust pollution and water pollution and villagers as well as School students are also facing so many problems. He also mentioned that there is a High School functioning in Marthapur village but adjacent to the boundary wall of the High School huge quantity of solid waste dumped causing very nuisance in the surrounding area. He requested to the District Administration to take necessary steps to shift the accumulated solid waste from the High School boundary wall premises. Finally, he urged to the District Administration that as the Lessee of sand mine and during transportation of sand through sand loaded vehicles are not adhering pollution control norms and speed limit, so the tendering process of Marthapur Sand mining should be closed. He submitted one written representation before the panel members is annexed separately.

# 03 Sri Rajendra Malik, Sarpanch, Marthapur village

He expressed that people of Marthapur village elected him as Sarpanch of Marthapur Gram Panchayat. If villagers are facing problems with respect to sand mining activity, then Sarpanch has to solve the issues faced by the villagers. Earlier sand loaded trucks were passing through this road without covering the trucks by Tarpaulin causing dust pollution in Marthapur village. This single road is being used by villagers, school children and movement of sand loaded and unloaded trucks. He mentioned that Marthapur villagers are completely using this single road and during plying of vehicles on this road causes dust pollution and water pollution. He said that he will definitely support

the views expressed by the villagers. He finally told that for the benefit of the Marthapur village, whatever final decision will take by the villagers site, he will support them.

# 04 Sri Umesh Chandra Nanda, Marthapur village

He expressed that during the last tendering process of Marthapur sand quarry there was a dispute happened between local Tahasildar and villagers. Few fays before one sand loaded truck have damaged his house. Even yesterday one sand loaded truck has damaged one electric pole for which distribution of power could not supplied to this village for few hours. He mentioned that sand loaded trucks are moving through this village road from 6.00 AM to 10.00 PM without covering tarpaulin and other pollution control measures for which villagers as well as School students has been suffering due to dust pollution. He said that with this type of sand mining activity Government is generating revenues but he mentioned that there are many ways available to generate revenues but why the Government is completely depends upon this sand mining tendering process. He expressed that this type of irregular activity has taken to the knowledge of local Revenue Inspector but not taken any steps to control it. He urged to the District Administration that during sand mining activity the mine proponent should follow the guideline in all respect and to ensure that sand mining is done in environmentally sustainable and socially responsible manner.

# 05 Sri Bhimsen Parida, Marthapur village

He expressed that opening of sand mine in this area & production will lead to more development of surrounding villages and more employment generation of the area. He mentioned that this is the only single road which is being used by villagers, school children and movement of sand loaded and unloaded trucks. He said that while plying of sand loaded vehicles through this village road, the respective trucks are not following pollution control measures and causing dust pollution in the adjoining area. He requested to the Lessee that while plying of

sand loaded trucks within this road, they should adopt tarpaulin covering of vehicle, speed restriction during School timing, proper dust suppression measures by water sprinkling. The lessee should maintain village roads. He urged to the District Administration that during sand mining activity the mine proponent should follow the guideline in all respect and to ensure that sand mining is done in environmentally sustainable and socially responsible manner otherwise the villagers will not allow sand mining activity.

#### 06 | Sri Sridhar Rout, Badmul village

He supported the views expressed by the previous members. He mentioned that this Marthapur sand quarry has been operating by different Lessee since long time and they did not maintain proper pollution control measures and for villagers expressed their unhappiness about sand mining project. This is the first time Government took over this sand quarry and conducting public hearing by following all types of Government notified guidelines. He expressed that the proposed sand mining project will lead to development in the area and also for locals. He urged to the District Administration that with the proposed sand mining project the lessee shall provide sand to the villagers either minimum reasonable price or free of cost. He urged that while plying of sand loaded vehicles through this village road, they should adopt tarpaulin covering of vehicle, speed restriction while movement of School children during School timing, proper dust suppression measures by water sprinkling. The lessee should maintain village roads.

#### 07 Sri Chandan Mishra, Marthapur village

He expressed that if local sand mining starts the sand price will goes down and all the local villagers as well as local contractors will be benefitted. He said that due to very high price of sand the villagers are not able to do their in-house civil works. Local contractors are similarly facing problems in respect to Government construction projects. He expressed that the proposed sand mining project will

lead to development in the area, generation of government revenues and also employment generation for locals. He finally requested to the District Administration to give necessary permission as soon as possible. He urged to the District Administration that during sand mining activity the mine proponent should follow the guideline in all respect and to ensure that sand mining is done in environmentally sustainable and socially responsible manner.

## 08 | Sri Nirakar Das, Adipur village

He expressed that Marthapur sand quarry is situated within maximum area (about 90%) under Adipura village but till date no development happened in Adipura village. Without elaborating anything in detail he did not support the proposed sand mining project.

# 09 Sri Nirmal Chandra Sahu. Adipur village

He expressed that Marthapur village is having one Market and all the sand loaded vehicles were plying within the market area causing heavy fust pollution. He urged to the District Administration that during sand mining activity the mine proponent should follow the guideline in all respect and to ensure that sand mining is done in environmentally sustainable and socially responsible manner. The lessee should provide proper water sprinkling within the market area is during movement of Trucks / Tractors.

# 10 Sri Debanarayan Nanda, Marthapur village

He expressed that there is one Primary School (Saraswati Sishu Mandir) and one High School exists adjacent to Marthapur village road. The sand loaded vehicles are used to ply over this road without adopting pollution control measures and over speed. During school opening and closer timing students are facing many problems. He said that this issues have taken to the knowledge of Sarpanch of Marthapur Gram Panchayat at many times but the Sarpanch could not taken any steps to solve the problem. He said that he is not at all against the sand mining activity but during the course of sand mining and

during sand transportation they should follow pollution control and speed limit guideline in all respect otherwise school children may face accident. He urged that while plying of sand loaded vehicles through this village road, they should adopt tarpaulin covering of vehicle, complete restriction of movement of sand loaded trucks during School timing, proper dust suppression measures by water sprinkling. The lessee should maintain village roads. Expecting better employment opportunity and further development activities in the periphery, he made a strong opinion in favour of the proposed sand mining project and requested to the Administration to issue Environmental Clearance against the proposed project.

## 11 Sri Babaji Bhol, Marthapur village

He expressed that about four months before there was a dispute happened between lessee and Marthapur villagers. He urged to the District Administration that during sand mining activity the mine proponent should follow the guideline in all respect and to ensure that sand mining is done in environmentally sustainable and socially responsible manner. He finally requested that during sand mining project the lessee shall provide necessary assistance towards development of Marthapur village Shiva Temple. He expressed his opinion in favour of the proposed sand mining project.

#### 12 Sri Sribatsa Sahu,

He expressed that there is one Primary School (Saraswati Sishu Mandir) and one High School exists adjacent to Marthapur village road, so during plying of sand loaded vehicles through this village road, they should adopt complete restriction of movement of sand loaded trucks during School timing particularly 9.000 AM to 10.30 AM and 3.30 PM to 5.00 PM. All the trucks should maintain tarpaulin covering, proper dust suppression measures by water sprinkling. He expressed his opinion in favour of the proposed sand mining project.

#### Observation:

Generation of local employment opportunity, repair and maintenance of village road, supply of sand to the locals with reasonable price and adequate air and water pollution control, restriction of movement of sand loaded trucks during School timing, tarpaulin coverage on trucks etc. were the most important issues emerged during the discussion.

Dr. Anup Kumar Mallick, Regional Officer, State Pollution Control Board, Angul & representative of State Pollution Control Board, Odisha, prepared the summary of the public hearing proceedings accurately reflecting the views and concerns expressed by the speakers with the inclusion of comments of the applicant read over to the audience at the end of the meeting explaining the contents in the ODIA Language and the agreed minutes of public hearing meeting was prepared. The statement of issues and concerns of public with the comments of applicant, prepared in Odia and English language is annexed herewith separately.

The President of Public Hearing meeting Sri Udaya Kumar Mohapatra, Additional District Magistrate (Revenue), Dhenkanal District, ratified the minutes of meeting and with the views and demands of public. He then delivered vote of thanks to the public for extending co-operation in smooth conducting of the public hearing proceedings.

The meeting was ended with thanks to the chair.

IN VILLAGE MARTHAPUR UNDER BHUBAN TAHASIL OF DHENKANAL DISTRICT.

#### ISSUES RAISED BY PUBLIC

The issues raised at the public hearing meeting are mainly two fold. These are issues concerning to pollution due to proposed sand mining activity and its mitigation and issues relating to development of the area i. e, peripheral development.

The issues concerning to control of pollution are

 Dust suppression and water pollution control

The issues concerning to development of the area are:-

- 2. Local employment opportunity.
- Provision for repair and maintenance of village roads
- Strict adherence of sand mining guideline.
- Supply of sand to the locals with reasonable price/free of cost.
- Restriction of plying of vehicles during School time.

#### COMMENT OF APPLICANT

Sri Susanta Kumar Sahoo, on behalf of Lessee of Marthapur Sand Quarry of Dhenkanal District was present at the public hearing gave her comments to certain demands raised by public as follows.

- Dust suppression and water pollution control management practices will be complied as per norms of the State Government and as per the provision of Environment Protection Act. It will be maintained within village road as well as with market area.
- Regarding employment issue he expressed that the locals will be given priority in employment.
- To keep the village road in good condition, infrastructure facilities will be provided by the concerned Department of the State Govt.
- During sand mining Government guideline will be followed properly.
- He ensured to supply sand to the villagers with reasonable price.
- He ensured that speed restriction will be maintained during plying of vehicles during school timings and within village road area.


