Divisional Forest Officer, Dhenkanal Division, Dhenkanal on behalf of Governor of Odisha invites percentage bids in **Single Cover** in online mode for the civil construction works as detailed in the table, from the class of eligible contractors as mentioned in column – 6 (Six) registered with the State Government and contractors of equivalent grade / class registered with Central Government / MES / Railways for execution of civil works. The proof of registration from the appropriate authority shall be enclosed along with the bid. If successful, the bidder who has not registered under the State Government has to register under the appropriate registering authority of the State Government of Odisha in appropriate class of eligibility before award of the work.
