

Sealed quotations / tenders are invited during the extended period as mentioned below from interested reputed Travel Agencies / Tour Operators or private individuals for providing one Non AC / AC Diesel driven vehicles having seating capacity not more than ten & not less than four including driver, which shall conform to the Terms and Conditions (Annexure-I) for official use in Office of the Spl.LAR&R.O., R.I.P., Sukinda on monthly rent basis.

1. The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle. The Head Quarter of the Vehicle with Driver is fixed at the Office of the SPL.L.A.R & R.O., R.I.P , Sukinda i.e. Rengali Irrigation Colony, Jamuposi Dist- Jajpur.
3. The Driver should be well behaved, gentle and obedient in nature.

A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the Spl.L.A.R.&R.O., R.I.P., Sukinda and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
