






**Terms & Conditions :**

1. The Sealed Tender should reach in the office of the Block Development Officer, Sadar Dhenkanal on or before **16.12.2022** by 3.00 PM through Registered / Speed Post only.
2. The Tenderer shall have to enclose Bank draft amounting to Rs.5250.00 (Rupees Five Thousand Two Hundred Fifty) Only towards cost of Tender paper in shape of Bank draft in favour of the Block Development Officer, Sadar Block, Dhenkanal payable at Dhenkanal.
3. The Tender Paper received beyond the stipulated date, time and without the required documents shall be liable for rejection.
4. The tender papers shall be opened by the Block level committee on dt **17.12.2022** at 11.00 am in presence of Tenderers or their authorized representatives.
5. The intending Tenderers shall have to deposit the Earnest Money for Rs 50,000.00 (Rupees Fifty Thousand ) only along with the Tender paper in shape of Bank Draft in favour of the Block Development Officer, Sadar, Dhenkanal payable at Dhenkanal .
6. The Tenderer shall have to submit the self attestation copy of GST, PAN card and ID proof of the tenderers along with the Tender paper.
7. The earnest money will be refunded to unsuccessful Tenderers after finalization of the Tender.
8. The Tenderer should have to write the Rate clearly in words and figures in the Tender paper.
9. The highest Tenderer shall have to deposit the entire amount of the materials before lifting of the materials from the Block office premises within 3 days from the date of finalization of the tender.
10. The Tenderer shall have to deposit the entire amount in shape of Bank Draft in favour of the Block Development Officer, Sadar payable at Dhenkanal, falling which the earnest money shall be forfeited.
11. The weighing, lifting and Shifting Cost of the materials from the PS Godown premises shall be borne by the Tenderer .
12. The Tenderer shall have to remove the scrap materials from the Block office premises within 3 days from the date of issue of release order at their own cost.
