INVITATION FOR BIDS THROUGH e-Procurement

1. Divisional Forest Officer, Dhenkanal Division, Dhenkanal on behalf of Governor of Odisha invites percentage bids in **Single Cover** in online mode for the civil construction works as detailed in the table, from the class of eligible contractors as mentioned in column – 6 (Six) registered with the State Government and contractors of equivalent grade / class registered with Central Government / MES / Railways for execution of civil works. The proof of registration from the appropriate authority shall be enclosed along with the bid. If successful, the bidder who has not registered under the State Government has to register under the appropriate registering authority of the State Government of Odisha in appropriate class of eligibility before award of the work.

Bids received on line shall be opened at 11.00 AM on dt. **28.12.2022** in the office of the Divisional Forest Officer, Dhenkanal Division, Dhenkanal in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of sale and receipt of the bids as specified, the bids will be opened on the next working day at the same time and venue.
8. The bidder shall have to furnish a **"BID Security declaration"** as per the Office Memorandum No.8943 dtd.18.03.2021 of Finance Department, Government of Odisha in lieu of Bid Security in the format annexed Form of Bid1Security Declaration along with the bid.


