



In pursuance to the instructions communicated vide letter No. 16002 dated 07.11.2022, No. 17502 dated 26.11.2019 & 17701 dated 30.11.2019 of the Managing Director, OSCSC Ltd., Bhubaneswar, the said tender was invited through newspaper advertisement as well as hoisting in the district website.

As two nos. of applications were received and the Tenderers participated, the Committee felt that it was improper to complete the tender process with 2 applications only and unanimously decided to extend the timeline for inviting of application for the said purpose for another 7 days more that is to be opened on 23.12.2022 and the rescheduling of the Programme to be made accordingly keeping all other terms and conditions as it is.
