PROCEEDINGS OF THE PUBLIC HEARING MEETING CONDUCTED ON 02.11.2022 AT 11.00 AM AT SAPTASAJYA VILLAGE (NEAR BANADURGA TEMPLE) UNDER DHENKANAL SADAR OF DHENKANAL DISTRICT IN RESPECT OF ENVIRONMENTAL ASSESSMENT FOR ESTABLISHMENT OF M/s INDALC SPIRITS Pvt. Ltd. FOR 100KLD CAPACITY GRAIN BASED DISTILLERY UNIT ALONG WITH CO-GENERATION POWER PLANT OF 3.0 MW AT VILLAGE SAPTASAJYA UNDER DHENKANAL SADAR TAHASIL OF DHENKANAL DISTRICT.

Public hearing in respect of Environmental Assessment for Establishment of M/s Indalc Spirits Pvt. Ltd. for 100 KLD capacity grain-based distillery unit along with Cogeneration Power Plant of 3.0 MW at Village Saptasajya under Dhenkanal Sadar Tahasil of Dhenkanal District.

Sri Ramesh Chandra Sethi, Additional District Magistrate (General), Dhenkanal District, supervised and presided over the meeting, assisted by Dr. Anup Kumar Mallick, Regional officer, State Pollution Control Board, Angul and the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset Dr. Anup Kumar Mallick, Regional Officer, SPC Board, Angul welcome the other panel member and the public, gave an introduction about the guidelines to be followed for the public hearing in the light of EIA Notifications 2006 in respect of Environmental Assessment for Establishment of M/s Indalc Spirits Pvt. Ltd. for 100 KLD capacity grain-based distillery unit along with Co-generation Power Plant of 3.0 MW at Village Saptasajya under Dhenkanal Sadar Tahasil of Dhenkanal District.

Sri Jagabandhu Bisoi, Consultant of this project and Sri Akash Agarwal, Director of M/s Indalc Spirit Pvt. Ltd. addressed the committee members and assembled public and gave a brief description about the proposed project. He also briefed about Establishment of M/s Indalc Spirits Pvt. Ltd. for 100 KLD capacity grain-based distillery unit At Village Saptasajya under Dhenkanal Sadar Tahasil of Dhenkanal District with the peripheral development work that had been taken up in this area and made a presentation about the environmental management, pollution control measures, solid waste-management of the related project. The copy of the statement of the industry read out at public hearing proceedings is enclosed.

Regarding public hearing of M/s Indalc Spirits Pvt. Ltd. for 100 KLD capacity grain-based distillery unit At Village Saptasajya under Dhenkanal Sadar Tahasil of Dhenkanal District was publicized at one English Daily newspaper and one Odia daily newspaper before one month. It was also publicized at the office notice Board of Saptasajya Gram Panchayat office, Tahasil Office Dhenkanal Sadar, Jilla Parisad Office Dhenkanal, Block Chairman Office, Dhenkanal and local villages of Saptasajya Pada, Badagila, Kumuning, Majhisahi and Bankual etc.

Dr. Anup Kumar Mallick, Regional Officer, State Pollution Control Board, Regional Office, Angul & representative of State Pollution Control Board Odisha then invited the public to present their views about the proposed project on environmental consideration.

The views expressed by various speakers are as follows:

01 Sri Abimanyu Behera, Sarpanch, Saptasajya village

He expressed as the representative of industry has explained about the advantage & disadvantage of establishing of this unit with proposed pollution control measures to be adopted for this unit and proposed CSR activities for the nearby villagers. He explained that if the industry emits untreated dust to the atmosphere which will cause air pollution, then they will raise complaint. Similarly, if the industry discharge untreated wastewater and solid waste material to the nearby water body/nallah then they will g for mush agitation. He

said that the industrial authority should discuss with the nearby villagers about the proposed CSR activities to be implement for the development of this area and simultaneously the villagers should feel the local developments with the establishment of this industry. Finally, he requested to the villagers to render their opinions about the proposed industry which are required to comply to the condition and which are not required by the villagers.

02 Sri Sanjib Tudu, Majhi Sahi

He mentioned that he was completely unaware about the public hearing and about the proposed project. He expressed that only two days before the Sarpanch informed him about the public hearing which will be conducted on 2nd November. The panel members informed us about the proposed industry which will be establish in this area but we still are unaware of the advantages and disadvantages of this industry and what benefits will get by the villagers. He mentioned that he is residing very close to the proposed project site and the villagers should give some time to think about the project properly. He said that this is a tribal dominated area where there are four villages comprising about 800 families. They mostly depend upon cultivation. The bulk of the resources used come from animals and their products, trading, supplemented by some horticulture etc. The domestication of vegetables/crops and animals led the agricultural activities for them to earn their livelihood. As the Government officials described about the project but as per his views and requested to held up the project for some time till complete discussion with the nearby village members. The villagers should able to know about the details of the project with possible sources of pollution and proposed pollution control measures in respect to air, water and solid waste management. He told with his single opinion industry cannot establish. If the villagers will support then only the industry can able to establish. He is not against the industry but he requested that the plant authority should have proper plan so that one side industry will be benefitted as well as villagers will not face any loss of environment. Plant establishment may provide employment to some villagers but can't employ one

each member from all 800 families and moreover our villagers do not prefer job, rather they are happy with their farming, beautiful environment and village. And this plant may create pollution and can deteriorate the atmosphere, waterquality and crop production. He mentioned that the consultant has read out the water quality of this area which is within the permissible limit. But he said that the villagers don't see the water quality analysis report. For this project there must be requirement of water for which the industry must dig bore well. Most of the villagers using nallah water for their bathing purposes. If the industry will use ground water, so after few years this area will face shortage of ground water level. If villagers will raise complaint to the Collector / District Administration and if the Collector transfers, then the new officer will inform to the villagers that as he has joined now and does not have any information about the past issues. So, it will take some time to solve the problem. At the beginning the Director of this project mentioned about the advantages of this proposed project. But as per his opinion that Livestock production constitutes a very important component of the agricultural economy to the villagers almost all of the resources produced are derived from animals and their products, with some trade for other agricultural products he requested to close the project proposal. As villagers just now came to know about the proposed project they cannot go for NOC. He finally requested to the villages to speak their views about the proposed project.

03 Sri Jitendra Kumar Nayak, Saptasajyapada, Saptasajya village

He expressed that no notice regarding Public Hearing was circulated in their villages and was also not publicized through Loud speakers in the village, and no information was provided to them. Two days before local Sarpanch has informed them regarding public hearing. According he came here to speak few words about the proposed project. The villagers are mostly poor households. People living in villages are not very skilled so the maximum population of villages is engaged in agricultural activities. He is not concerned about the establishment of the proposed industry. He is not aware about environmental

damage /loss may happen due the establishment of proposed industry. Industry leads to air pollution and ultimate there will be loss of crop production. There is a nallah (Ghantia nali) flows close to the proposed project site. About four villagers are completely depends on this nala water in respect to use of bathing, drinking and irrigation purposes. The discharge of untreated water may affect water quality and ultimately affect the crop yield and spread of diseases. He expressed that establishment of this industry may bring loss to farmers which may lead the farmers to commit suicides. There is no requirement of industry. He requested the government officials to look around this beautiful environment and requested to not exploit or hamper this by constructing plant in this area. He expressed that they mostly belong to farmers and need no job and are very happy with their village environment.

04 | Sri Mahendra Sahoo, Kumuning village

He expressed that no notice regarding Public Hearing was circulated in Panchayat Office and was also not publicized in nearby village. They even expressed that they got to know about the industry on the same day itself and knew nothing about it earlier. He is not aware about environmental damage /loss may happen due the establishment of proposed industry. He expressed that villagers are completely depends on this nala water in respect to use of bathing, drinking and irrigation purposes. So, government should think properly and shall not damage the local environment. He requested to close the project proposal.

05 Sri Sarat Chandra Nayak, Saptasajyapada, Saptasajya village

He expressed that only three days before the nearby villagers were informed about the public hearing for ethanol based proposed project. He said that that no notice regarding Public Hearing was circulated at Saptasajya pada village. He expressed that the villagers are mostly workers or farmers and are dependent on crop and cattle farming. So, he totally disagreed and also submitted a letter opposing the establishment of industry.

06 Sri Trilochan Sahoo, Saptasajyapada, Saptasajya village

He said that his village is situated about 500-meter distance from the public hearing venue. He expressed that this Ghantia Nala runs through these villages and this nala is one of the sources to meet up the requirement for agriculture, bathing of villagers and drinking source of domestic animals. Agriculture is the only source of livelihood for the people. Most of the families earn a living through agriculture and cattle farming. He mentioned that industry may be establish in this area but there should not be any type harassment to the nearby farmers. Since childhood he knows that there is a slogan that is "Jay Jawan Jay Kashan". He requested to Hon'ble Prime Minister of India that farmers shall not be disturbed at any cost. They should be protected. The industry shall close its project.

07 Sri Susanta Kumar Sahoo, Badagila village

He expressed that local Sarpanch has received letter regarding public hearing of the Ethanol based project. Sarpanch has informed him about the public hearing with advantages of ethanol-based project. Unlike petroleum, ethanol is a renewable resource. It causes less pollution and low cost. But he told that He is not concerned about the establishment of the proposed industry. He is not aware about environmental damage /loss may happen due the establishment of proposed industry. Industry leads to air pollution and ultimate there will be loss of crop production. He expressed that no industry has been established in our panchayat and they are least known about any industry. And if any industry is established, we have a fear of pollution entering our village. We expressed that by any means farming should not be affected. He also expressed that the establishment of the industry may pollute the water-body which is their only source of utilization like bathing, farming, drinking water for animals etc.. He said that villagers should be well informed about the industry and its purpose in detail. He then said that company can only give employment to 240 villagers but fact is 4 to 5 thousand people are dependent on farming are mostly workers or farmers and are dependent on crop and cattle and ultimately on water and

this industry establishment could deteriorate the atmosphere, water-quality and crop production. He asked everyone that if everyone will agree the industry to be established then only the industry should be established. He also said that if company is established then the villagers should be given first priority to recruit local employment in all respects and CSR activities should be well conducted for the maximum development of the village. But if company is established and if we face problems by its establishment then we shall definitely conduct strikes and mass movements.

08 Smt. Chaya Nayak, Saptasajyapada, Saptasajya village

She expressed that they are totally dependent on farming and if industry is established their croplands will be destroyed due to pollution and they will all be unemployed. So, she said that that they will not allow the establishment of industry in their village and if company is established, they will definitely conduct strikes and mass movements.

09 Sri Prafulla Kumar Behera, Kumuning village

He welcomed the gathering of the public hearing and said that that notice regarding Public Hearing was circulated in Panchayat Office only two days before and villages are completely unaware about the proposed project. The establishment of industry will affect water systems as they may discharge effluent water, mostly during rainy seasons to the nearby Ghantia Nala, which is their only source for drinking, bathing, farming, etc. He also said that their villagers are mostly farmers and said that company can only give employment to 260 people from the nearby village but total population of nearby villages is about thirty-eight hundred and what they will do. He said that we are in a very good condition and are happy with all we have and he requested not to establish any industry here as we all know the polluted life of industrial places like Angul and utmost problems faced by them. So, he totally disagreed to the establishment of industry in their village.

Ltd. FOR 100KLD CAPACITY GRAIN BASED DISTILLERY UNIT ALONG WITH CO-GENERATION POWER PLANT OF 3.0MW AT VILLAGE AT- VILLAGE SAPTASAJYA UNDER SAPTASAJYA SADAR OF ANGUL DISTRICT.

ISSUES RAISED BY PUBLIC

The issues raised at the public hearing meeting are mainly two-fold. These are issues concerning to pollution due to proposed industry and its mitigation and issues relating to development of the area i. e, peripheral development. The issues concerning to control of pollution are

- 1. Air Pollution Control
- 2. Water pollution control
- 3. Solid Waste Management
- 4. Protection of Ghantia nallah and not to discharge any type of wastewater.

The issues concerning to development of the area are:-

- 5. Local employment opportunity.
- 6. Proper CSR activities
- 7. Proper discussion with the villagers in respect to details about the project.

COMMENT OF APPLICANT

Sri Prakash Kumar Rout, Director of M/s Indalc Spirits Pvt. Ltd. was present at the public hearing gave his comments to certain demands raised by public as follows.

- 1. Air Pollution Control management practices will be complied as per norms of the State Government and as per the provision of Environment Protection Act.
- 2. Water Pollution Control management practices will be complied as per norms of the State Government and as per the provision of Environment Protection Act.
- 3. Solid Waste management practices will be complied as per norms of the State Government and as per the provision of Environment Protection Act.
- 4. Adequate treatment facility will be provided and in all season no wastewater will be discharged to outside the factory premises.
- 5. Regarding employment issue he expressed that the locals will be given priority in employment.
- 6. He ensured to provide necessary CSR activities in consultation with District Administration and local village representatives.
- 7. He ensured that after necessary discussion with the villagers' subsequent steps will be followed.


