Block Development Officer, Bhuban invites percentage (%) sealed tenders in conformity with the Tender Call notice(TCN) from the registered contractors of state PWD/M.I/Irrigation /Rural works/CPWD/PHD/for the following works under Bhuban Block to be eventually drawn in PWD F-2 (Now P-1) contract as detailed below. The amount put to tender and bid security may be changed and confirmed at the time of selling of tender documents. Bid identification No-01/2022-23/BDO, Bhuban.

2. The details of work including the estimated cost, Tender value, EMD, required, Class of contractor, completion time, cost of tender paper, place of selling to tender paper etc. are available at the Panchayat Samiti , Bhuban from 20.02.2023 to 01.03.2023 during office hours(working days) only. The intending tenders will purchase tender papers from office of the BDO, Bhuban.
3. The cost of tender paper(Non-refundable) in shape of Bank draft/Bankers Cheque (drawn in any Nationalized Bank in favour of BDO, Bhuban, payable at Canara Bank, Bhuban should be enclosed with the tender documents.
4. The tender papers will be sold from 20.02.2023 to 01.03.2023(working days) only up to 05.30PM working days only in the office of Panchayat Samiti, Bhuban and the sealed tender in complete shape will be received from 20.02.23 to 01.03.23 up to 05.30 PM in the office of the Panchayat Samiti, Bhuban through registered post/Speed post(Working days) only. The tender papers received after the stipulated date and time will not be considered. No tender papers will be received by hand or by courier service. The tender papers shall be opened on 03.03.2023 at 11 A.M onwards in the Office chamber of the Block Development Officer, Bhuban in presence of the bidders or their authorized representatives having written authorization for the purpose. If the office happens to be closed on the last date of sale and receipt of the bids as specified, the bids will be sold and received on the next working day at the same time and venue and opening of the bids accordingly extended. Similarly, if the office happens to be closed on the date of opening the bids will be opened on the next working day at the same time and venue.
5. All documents should be self-attested failing which the tender is liable for rejection.
6. The following documents should be furnished along with the tender papers failing which the tender is liable for rejection.
 - a) No EMD is required, but earn money deposit (Bid Security Declaration) should be submitted as per prescribed Performa.
 - b) Money receipt of TCN shall be enclosed original.
 - c) No relation certificate to the Block Development Officer, Bhuban
 - d) Signed copy of TCN and price-bid duly filled and signed by the tenderer.
 - e) Self-attested copy of PAN cards and GSTIN, GST reg. certificate
 - f) An affidavit in support of the authenticity of the documents should be attached with tender paper.
 - g) The Engineer contractor and SC of availing exemption of EMD should submit an affidavit to the effect that he/she has not availed exemption of EMD facility more than three times in the current financial year.
 - h) SC/ST contractor desirous of availing price preference over General category contractors should submit an affidavit in support of caste certificate and attested copy of recent caste certificate.
7. The bidder should submit the past performance of the contractor.(Experience certificate of similar nature of work)
8. The successful bidder whose tender is accepted is to deposit at the time acceptance of tender furnish EMD of appropriate value as per col. 5 against the work in shape TDR deposit receipt schedule Bank/Kissan Vikash Patra/National saving Bank certificate/Post office time deposit from scheduled bank(valid for minimum one year from date of receipt)/ Post office pass book

- (valid for minimum one year from date of receipt) duly pledge in favour of BDO, Bhuban must accompany the tender at the time of agreement, otherwise their tender will be liable for rejection.
9. Addl. Performance security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/ rates that the estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of demand draft/ term deposit receipt pledged by contractor before agreement in favour of the Block Development Officer, Bhuban otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder as per works department office memorandum letter No.1437/31.01.2023.
 10. **All the tenders where rate quoted is "15%" and above the scheduled rate will be rejected. If more than one bid is quoted (decimal up to two numbers will be taken for all practical purposes) either at the estimated cost put to tender or less than the estimated cost put to tender, the tender accepting authority will finalize the tender through a transparent lottery system, where all bidder/ their authorized representatives, the concerned SE/Executive Engineer of concerned Division and DAO will remain present.**
 11. The detailed list of successful bidders against each work will be displayed in the notice board. The successful bidders will collect the letter of acceptance from the office of the undersigned within seven days from the date of declaration of list of successful bidders on the notice board in order to avoid postal delay for early execution of the work. No further claim will be entertained for non-receipt of the acceptance letter.
 12. The EMD amount is to be forfeited if the successful tender backs out/ refuse from the offer of acceptance of tender by the competent authority. **EMD shall also be forfeited if the tenderer withdraws his/her bid during the tender period.**
 13. The cover containing the tender paper should be super scribed the top "Tender work for Pachayat Samiti, Bhuban" or the name of the work should be mentioned clearly.
 14. The tender paper will be received through **Registered post/Speed post** only. No tender will be received by hand or courier services. The undersigned will not be held responsible for any delay in postal service.
 15. In case of short fall of any required documents, the tender paper is liable for rejection.
 16. Since work is time bound programmed, the tenderers have to complete the same within the specified time, failing which; penalty of 10% will be imposed as per OPWD code.
 17. Provision of OPWD codes as well as instruction and guidelines of Govt. of Odisha are applicable.3
 18. The tenders are to show his original documents (Contractor License, PAN card, GSTIN, GST certificate, Caste Certificate in case of SC/ST/Engineering contractor etc.) at the time of opening of tender papers.
 19. The quoted percentage rate should be mentioned clearly in figure and words.
 20. The authority reserves the right to reject any or all tenders without assigning any reason thereof.
 21. The bidder is required to submit "Bid security declaration" in shape of an affidavit to the effect that, if they withdraw or modify their bids during the period of validity etc., they will be suspended for the time specified in the tender documents. The name of the work and the authority to which the tender has been submitted must be mentioned in the affidavit.


