Sealed Tenders are hereby invited in the enclosed format by the Block Development officer, Bhuban from the intending purchasers / registered firms having valid GSTIN & PAN No. for auction sale of scrap materials of IM-II hand pump spare parts lying available in the store of Panchayat Samiti, Bhuban.

Terms & Conditions:

1. The Sealed Tender should reach in the office of the Block Development Officer, Bhuban on or before Dt. 28.02.2023 by 3.0 PM through registered / Speed Post Only.
2. The Tender shall have to enclose Bank Draft amounting to Rs. 5250.00 (Rupees Five Thousand Two Hundred Fifty) only towards cost of Tender Paper in shape of Bank Draft in favour of the Block Development Officer, Bhuban Block, Dhenkanal Payable at Bhuban.
3. The Tender Paper received beyond the stipulated date, time and without the required documents shall be liable for rejection.
4. The Tender paper shall be opened by the Block Level committee on Dt. 01.03.2023 at 11.0 Am in presence of Tenderers or their authorized representatives.
5. The intending Tenderers shall have to Deposit the Earnest Money for Rs. 50000 /- (Rupees Fifty Thousand) only along with the Tender Paper in shape of Bank Draft in favour of the Block Development Officer, Bhuban Block, Dhenkanal Payable at Bhuban.
6. The Tenderer shall have to submit the self-attestation copy of GSTIN, PAN card and ID proof of the tenderers along with the Tender Paper.
7. The earnest money will be refunded to the unsuccessful tenderers after finalization of the Tender.
8. The Tenderer should have to write the rate clearly in words and figures in the Tender Paper.
9. The highest Tenderer shall have to deposit the entire amount of the materials before lifting of the materials from the Block Office premises
10. The Tenderer shall have to deposit the entire amount in shape of Bank Draft in favour of the Block Development Officer, Bhuban Block, Dhenkanal payable at Bhuban failing which the earnest money shall be forfeited.
11. The weighing, lifting & shifting cost of the materials from the Block store shall be borne by the Tenderer.
12. The Tenderer shall have to lift the scrap materials from the Block office premises within 03 (Three) days from the date of Issue of release order at their Own cost.




