





Block Development Officer, Kamakhyanagar on behalf of Governor of Odisha invites percentage rate bids for the works details in the table from class of contractors mentioned in Col.-4 below registered with the State Government and contractors of equivalent grade / class registered with Central Government / MES / Railways to be eventually drawn up in PWD F-2 (Now P-1) form for execution of civil works, on production of definite proof from the appropriate authority. But successful bidder of other State / MES / Railway / CPWD in equivalent rank has to register under the State PWD before signing the agreement. The bidders may submit bid for the following works.

Bid documents consisting of specifications, the schedule of quantities and the set of terms and condition of contract and other necessary documents can be seen in all the offices issuing the documents as specified in Col.- 6 above and in the office of the undersigned during office hours every day except on Sunday and Public holidays till last date of sale and receipt of the tender papers. Interested bidders may obtain further information at the same address.
3. The sale and receipt of the bid documents shall start **from 10.00 AM on dt. 02.03.2023 up to 5.30 PM. on dt. 13.03.2023**. Bids shall be sold and received in the office as stated in the Col.- 5 above as well in the office of the undersigned.
4. The bid will be opened on **dt. 15.03.2023 at 11.00 AM** in the office of the undersigned in the presence of the bidders who wish to attend. If the office happens to be closed on the last date of sale and receipt of the bids as specified, the bids will be sold and received on the next working day at the same time and venue and opening of the bids accordingly extended. Similarly, if the office happens to be closed on the date of opening the bids will be opened on the next working day at the same time and venue.
5. Bids must be delivered in the tender box having Identification No. Panchayat Samiti, Bhuban – 02/2022-23.
6. Bidding documents requested by mail will be dispatched by registered / speed post on payment of an extra amount of Rs.500.00 (Rupees five hundred) only over the cost of the document. The BDO, Bhuban will not be held responsible for postal delay if any.
7. The tender should be accompanied with the attested true copies of the valid registration certificate, GSTIN and PAN card which are mandatory and the original certificate are to be produced within three working days of opening of the tender before Block Development Officer, Bhuban for verification otherwise his / her bids shall be declared as non-responsive and thus liable for rejection. Also, the tenderer should satisfy the eligibility criteria, provided in the relevant clauses of the bid documents (DTCN).
8. Bidder can submit one tender paper for a particular work. Submission of more than one tender paper by a bidder for a particular tender will be liable for rejection of all such tender papers.
9. All the tenders where rate quoted is "15 %" and above the scheduled rate will be rejected.
10. The bidder is required to submit "**Bid Security Declaration**" in shape of an affidavit to the effect that, if they withdraw or modify their bids during the period of validity etc., they will be suspended for the time specified in the tender documents. The name of the work and the authority to which the tender has been submitted must be mentioned in the affidavit.
11. Other details can be seen in the bidding documents.
12. The enclosures other than the D.T.C.N. should be page numbered and signed by the contractor.
13. Total No. of enclosures submitted by him / her in Numbers and words as per relevant clause of DTCN.
14. The authority reserves the right to reject any or all tenders without assigning any reason thereof.


