Quotation call Notice

Sealed quotations in plain paper are invited from the interested suppliers for supply of 120 Quintal of good quality paddy straw for feeding of the animals sheltered at State Go-Sadan, Babandha as per terms & conditions of the quotation mentioned in Annexure-I. The interested suppliers should submit their quotations along with all requisite documents to the CDVO Dhenkanal through speed post/registered post/by hand latest by Dt. 13.04.2023 by 11 AM & will be opened on the same day at 12 Noon in presence of the technical committee as well as the quotationers or their authorised representatives. The authority reserves the right to reject any or all quotations without assigning any reason thereof.

Terms & Conditions (Annexure-I)

1. The interested suppliers should submit their quotations in a sealed envelope. All the pages of the quotation documents should be signed by supplier.
2. The sealed envelope containing quotation documents must be delivered to CDVO Dhenkanal by Speed post/registered post/by hand with superscribed "Quotation for supply of paddy straw" in capital letters. Quotations received after due date will not be entertained & liable for rejection.
3. Each quotation must be accompanied by the following documents.
 - a) Quotation in plain paper.
 - b) Photocopy of the aadhar card of the supplier.
 - c) Photo copy of the 1st page of Bank account of the supplier.
 - d) Self declaration for supply of good quality straw.
 - e) Demand Draft of Rs. 2000/- (Rupees two thousands) only in favour of CDVO Dhenkanal payable at Dhenkanal towards earnest money.
 - f) The quotation without earnest money will not be considered.
4. The amount quoted in terms of Rupees per Quintal shall be legible written in the quotation form & any alternation requires to be attested.
5. The amount quoted per quintal include cost of paddy straw loading, unloading & transportation charges which is to be delivered at State Go-Sadan, Babandha by the successful quotationer.
6. In case there is discord between the amount quoted in figures & words, the amount furnished in words will be taken as correct.
7. The earnest money of the unsuccessful quotationer will be refunded within 7 days after finalisation of the quotation process. Similarly the earnest money of the successful quotationer will be released within one month after supply of the required amount of paddy straw.

8. The payment of the supplier will be only released after supply of good quality straw as per verification report of the technical committee.

9. CDVO reserves the right to accept or reject any or all quotations without assigning any reason thereof & also has the rights to give supply order to L2 quotationer in case L1 quotationer failed to deliver required quantity of paddy straw in stipulated time mentioned.

10. In case any breach of any terms & conditions & failure to supply the required amount of paddy straw by the successful quotationer CDVO will have the right to cancel the order without assigning any reason thereof.

11. The decision of the technical committee on selection / rejection of the quotationer is final basing on the quotation submitted by the quotationers & quality of paddy straw supplied.

12. The supply paddy straw by the successful quotationer should be completed within 7 days of issue of the supply order.

13. Any legal dispute arises out of this is subject to Jurisdiction of Dhenkanal only.
