<u>ORDER</u>

Whereas the signatory of this order has been empowered U/s-2(1)of Epidemic Disease Act, 1897 read with Clause II of Covid-19 Regulations- 2020 framed by Government of Odisha to take effective measures for containment of the epidemic which has already been declared as a pandemic;

Whereas, the District Disaster Management Authority has the power to take necessary measures U/s 30 to 34 of Disaster Management Act,2005 to prevent the spread of this disaster;

Whereas, the objective of the administration is to go for immediate social distancing, enhanced active surveillance, ensure testing of all suspected cases as perneed;

And whereas, more than ten (10plus) employees as well as some of the Judicial Officers of District Judge Court, Dhenkanal has been detected Covid positive on dt.23.01.2022;

And whereas, it is felt necessary to contain any further possible spread of COVID-19 and perspective of public interest and for the sake of speedy completion of active surveillance in the containment zone.

Now therefore, in exercise of powers conferred under Disaster Management Act, 2005 and Order No.7554/R&DM(DM)/dt.29.12.2021 of Chief Secretary, Odish, I Sri Saroj Kumar Sethy, OAS (SS), Collector & DM, Dhenkanal do hereby declare Micro Containment Zone in the premises of District Judge Court, Dhenkanal for the period of 72 hours i.e from 7 A.M of 24.01.2022 to 7 A.M of 27.01.2022. The restrictions applicable to micro containment zones as per guidelines of H & FW Department shall be implemented & it will be enforced/ monitored under the direct supervision of the Sub-Collector & Empowered Officer, Dhenkanal. It is decided not to declare buffer zone adjoining to containment zone. The vehicular movement in totality both in public and private is stopped in the micro containment zone excluding the vehicles permitted for supply of essential items, medicines, medical emergency,health surveillance, sanitization and other necessary activities to be undertaken by District Administration/Executive Officer, Dhenkanal Municipality. All the shops and business establishments irrespective of the scale and size in Micro Containment zone will be closed with immediate effect. The supply chain of medicine and other essential items will be kept uninterrupted by the Executive Officer, Dhenkanal Municipality.

All inhabitants of the Micro Containment zone will stay in-door and this is to be followed without deviation. Violation will invite strict penal action as per Disaster Management Act-2005 and Epidemic Disease Act, 1897 & Covid-19 Regulations- 2020. The following officers will act as Nodal Officers to ensure smooth supply of essentials, sanitization, active survey & surveillance, law and order & others in the Containment Zone.

- 1. Assistant Fire Officer, Dhenkanal Maintenance of sanitation and sanitization of areas in nicro containment zone.
- 2. Tahasildar-Cum-Incident Commander, Dhenkanal Maintenance of Law & Order, enforcement and implementation of all activities relating to Micro Containment.
- 3. Executive Officer, Dhenkanal Municipality -Over all co-ordination
- 4. CDM & PHO, Dhenkanal– Health/Medical arrangements.
- 5. IIC, Dhenkanal, shall make necessary arrangement for immediate deployment of adequate police at the points of requirement and to be supervised accordingly.
- 6. CDM&PHO, Dhenkanal/ Executive Officer, Dhenkanal Municipality Active House to House Survey & Surveillance.
- 7. Overall Supervision & Monitoring- Sub-Collector, Dhenkanal.

Contact Tracing

There shall be intensive contact tracing in Micro Containment zones. Contacts of the confirmed and suspected cases will be line listed, tracked and kept under surveillance at home for 14days.

<u>Surveillance</u>

The area of Micro Containment zone will be under active surveillance. The CDM & PHO, Dhenkanal will mobilize required health staff immediately to conduct surveillancein Micro Containment zone. Supervisory Officers will be also named by the CDM & PHO, Dhenkanal. The active surveillance will start from 24.01.2022 and completed by 27.01.2022.

The CDM & PHO, Dhenkanal shall provide required numbers of masks, hand gloves, head covers to all surveillance team members & supervisors for conducting Active Surveillance in Containment zone and train them accordingly. The aforesaid process must be followed as per the guidelines of H&FW, Deptt. Govt. of Odisha & same must be ensured by CDM & PHO, Dhenkanal. All ILI and SARI cases either reported in the last 14 days by the IDSP or ascertained in course of Active Surveillance exercise will be tracked and reviewed thoroughly in Containment zone. Swab will be collected from all cases of confirmed contact history/Symptoms at the earliest for testing at the designated Labs.

This order will come into force with immediate effect without any dilution and shall remain enforced until **27.01.2022**.
