Quotation Call Notice

Sealed quotations are invited from interested reputed Travel Agencies/Tour Operators or private individuals for providing 01 no of Tiago/Bolt/Celerio (petrol) etc, which shall confirm to the Terms and conditions (**Annexure-A**) for official use in District Emergency Operation Center, Dhenkanal on monthly rent basis.

1. The vehicle must be in road worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Pollution Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The Driver of the vehicle must have a valid driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs. 5,000/- shall be deposited by the intending bidders in shape of Account Payee, Bank Draft drawn in favour of the Nizarat Officer, Collectorate, Dhenkanal and submitted along with the tender as security deposit. After completion of the tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge within Rs- 20000/- (twenty thousand) be quoted separately in the general bid information. (excluding fuel and lubricants)
6. The Vehicle must achieve a fuel efficiency of 17 kms per litre.
7. The details of the make and year of manufacture of the vehicle, registration no, mileage (kms covered per liter) and name of the driver with Driving License No and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender (**Annexure-B**).
8. The sealed Quotation completed in all respect should reach the undersigned by Registered Post/Speed Post/by hand only on or before 11/01/2024 by 5.00 PM and shall be opened on 12/01/2024 at 11 AM in presence of the bidders or their authorized representative. The sealed envelope must be superscribed with "Quotation for hiring of vehicle for DEOC, Dhenkanal".

9. The application form of quotation/ tender containing General Bid Information & Term and conditions for Hiring of Vehicle etc, will be available with Emergency Section, Collectorate, Dhenkanal on payment of Rs.1000/- or can be downloaded from the district website: <https://dhenkanal.nic.in/>. In case the application form is downloaded from the Government website, the applicant shall furnish a Demand Draft for an amount of Rs 1000/- (Rupees One Thousand) only towards the cost of application along with the application.


