


**TENDER NOTICE FOR COLLECTION OF CASHEW NUTS & APPLES OF STATE GO

Sealed tenders in plain papers are invited from the intending persons/institutions for collecting cashew nuts & apples from the cashew plantation field of state Go Sadan Babandha in Dhenkanal District for the year 2023-2024. The last date for receipt of sealed tender is Dt- 12.03.2024 up to 5pm and will be opened on Dt- 13.03.2024 at 3 PM in presence of the tender committee as well as the tenderers or their authorized representative. The tender papers should be submitted to the office of the undersigned through courier service or by Registered post. An amount equal to 20% of the quoted value should be deposited along with the tender papers in shape of Bank Draft in favour of the undersigned payable at SBI, Dhenkanal towards earnest money. The tenderers are required to furnish Sale-Tax, Income-Tax clearance certificate from the <sup>Competent</sup> ~~competent~~ authority. The sealed cover containing the quotation with other documents should be mentioned in capital letter "TENDER FOR COLLECTION OF CASHEW NUTS AND APPLES 2023-2024" should be addressed to the Chief District Veterinary Officer, Dhenkanal.

On acceptance of highest tender, the tenderers/institutions, earnest money so deposited will be converted towards Security deposit of the quoted value and 50% of the tender value should be deposited on the same day by the tenderer & the balance 50% amount including all taxes as admissible should be deposited within seven days after which the approval order will be issued failing which the cashew field will not be handed over and have no right to collect nuts & apples from the field & the earnest money so deposited will be forfeited. The department will not be held responsible for any natural calamity whatsoever. The Authority reserves the right to cancel the tender without assigning any reason thereof.
