
**Order**

3. She shall enroll under the new restricted defined " Contribution Pension Scheme as per O.M No.30132/F Dated.13.07.2006 of Finance Deptt.Odisha from the date of appointment.
4. She should join on duty before the District Panchayat Officer, Dhenkanal within 30 days from the date of issue of the order, failing which the appointment order shall be automatically cancelled.
5. She should submit the following documents at the time of her joining in the post.
  - a) Medical fitness certificate signed by Govt. Medical practitioner not below the rank of a Assistant Surgeon.
  - b) Two character certificates from two Gazetted Officers of State/Central Government at the time of joining.
  - c) Two pass post size photographs (self attested).
  - d) Copies of Certificates in support of her/his qualification and date of birth/ resident/caste (self attested).
  - e) Marital declaration, if married, having not more than one spouse living. In case the declaration is found false at any time he/she will be liable for termination from Government service.
  - f) Oath of allegiance to the Constitution of India.
  - g) The appointee should submit the "Attestation Form" immediately after joining for verification of Character and antecedents.
  - h) No Travelling Allowances is admissible to join in the post.
  - i) The appointees will be in probation for a period of 02(two) years with the effect from the date of joining.
