

Quotation /Tender Call Notice

Sealed quotations/tenders are invited from interested reputed travel Agencies/Tour Operators or private individuals for providing one no. of AC diesel/petrol driven vehicle having sitting capacity not more than five including driver, which shall conform to the term and conditions (Annexure-II) for official use in ICDS Project Office, Kamakhyanagar on required basis/monthly hiring basis within the maximum limit of 20,000/- per month.

1. The service provider shall have a valid OGST registration to participate in tendering.
2. The vehicle must be in road worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid registration certificate, insurance certificate, fitness certificate, pollution certificate, valid contract Carriage Permit, proof of up-to-date tax payment etc. which are mandatory for plying of vehicle.
3. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
4. The driver should be well behaved, gentle and obedient in nature.
5. A sum of Rs. 5000/- shall be deposited by the intending bidders, in shape of Account Payee Bank Draft drawn in favour of the CDPO, Kamakhyanagar and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
6. The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants)
7. The vehicle must achieve a fuel efficiency of 17 Kms per litre.
8. The details of the make and year of manufacture of the vehicle, registration No., mileage (KM covered per litre) and name of the driver with driving licence No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender (Annexure –II)
9. The quotation completed in all respect should reach the undersigned on or before **05.08.2024** by **1 PM** and shall be opened on dt **06.08.2024**. at **11 AM** in presence of the bidders or their authorized representatives.


10. The authority reserves the right to accept or reject any or all quotations without assigning any reason thereof.
11. The monthly rate of hire charges should not be exceed **Rs. 20,000/-** (Rupees Twenty thousand) only per month (excluding fuel and lubricants)

The application form of quotation /tender containing General Bid Information & Terms and conditions for hiring vehicles etc. will be available with ICDS Project, Kamakhyanagar on payment of Rs. 1000/- from **10 AM to 1 PM** the applicant shall furnish a Demand draft for an amount of Rs.1000/- only towards the cost of application along with the application.


