1. The engagement is purely temporary and terminable at any time without notice and assigning any reason thereof.
2. The appointee will be entitled to leave under the provisions of the Odisha Leave Rules, 1966 and shall abide by the Odisha Civil Services Conduct Rules; 1959 and O.C.S. (C.C. &A) Rules'1962.
3. He shall enroll under the new restricted defined " Contribution Pension Scheme as per O.M No.30132/F Dated.13.07.2006 of Finance Deptt.Odisha from the date of appointment.
4. He should join on duty before the District Panchayat Officer, Dhenkanal within 30 days from the date of issue of the order, failing which the appointment order shall be automatically cancelled.
5. He should submit the following documents at the time of his joining in the post.
 - i. Medical fitness certificate signed by Govt. Medical practitioner not below the rank of Assistant Surgeon.
 - ii. Two character certificates from two Gazetted Officers of State/Central Government at the time of joining.
 - iii. Two pass post size photographs (self attested).
 - iv. Copies of Certificates in support of his qualification and date of birth/ resident/ caste (self attested).
 - v. Marital declaration, if married, having not more than one spouse case the declaration is found false at any time he will be liable for termination from Government service.
 - vi. Oath of allegiance to the Constitution of India.
 - vii. The appointee should submit the "Attestation Form" immediately joining for verification of Character and antecedents.
6. No Travelling Allowance is admissible to join in the post.
7. The appointee will be in probation for a period of 02(two) years with effect from the date of joining.
8. He will attend counseling for allocation of place of posting at District Panchayat Office, Dhenkanal on the date of his joining.
