- 2) Manufacturing license (only for manufacturers) from Directorate of Agriculture & Food Production, Odisha, Bhubaneswar.
- 3) IT returns of last three year.
- 4) The Quoted party should submit the two-testing report of the products from the State Govt. /Central Govt. organization at the time of submission of Tender.
- 5) 100% organic certificate from any reputed organic station.
- 6) Pollution Certificate from Authorized Govt. Units.
- 7) Experience Certificate..

### I. OPENING OF TENDERS & TENDERS SCRUTINY:-

- i. Opening of Technical bids will be done in the presence of the tenderers or their authorized representatives and the Tender Committee will conduct preliminary scrutiny of EMD. Later on a detailed scrutiny will be taken up and those found to be in order will only be accepted.
- ii. Eligible financial bids in respect of those tenders whose technical bids are qualified will be opened in the presence of the qualified tenderers by the Tender Committee constituted by the Asst. Director of Sericulture, Dhenkanal.

**IV. ISSUE OF SUPPLY ORDERS & EXECUTIONS OF SUPPLIERS & PAYMENTS:-**

- 1) The party should supply the product within 10 days of the order.
- 2) The Sample of the product will be taken randomly from any supply place on the presence of the party and it will be sent to lab for the testing report
- 3) After receive of the testing report, the verification of the stocks will be done by the postdelivery inspection team and the payment will be made as per availability of the fund on online of the MGNREGA Scheme.
- 4) The Tender accepting authority shall have the right to alter the quantity finally ordered to the extent of 25% either way for requirement indicated in the tender document.
