6. Copies of supply orders in respect of Solar Streetlight, Torch light, Uniform (T-Shirt, Cap, Water Bottle), etc. The tenderer must show and submit the Photo copies showing credential of experience in other Division/Office/Department.
7. Tenderers have to mention the Company, Model, Manufacture year and detailed Technical specification of the Solar Light in the Technical Bid. The Tender Evaluation Committee will scrutinize and verify the model & specification on the same date and will open the Financial Bid of technical qualified bidders.
8. The bidder shall have to deposit the cost of tender paper @ Rs. 2,000/- for participation in the bid in shape of Bank Draft / Banker's Cheque etc in **favour of Divisional Forest Officer, Dhenkanal Forest Division**. The Tender cost is non-refundable in nature.

9. A sum of Rs. 1,00,000/- (Rupees One Lakhs) only towards in EMD Amount shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the **Divisional Forest Officer, Dhenkanal Division, Dhenkanal** submitted along with the tender paper as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
10. An under taking by the tenderer declaring that the documents submitted by him are true to the best of his knowledge and in case any thing contrary arises in future, the tenderer shall remain solely liable for that.
11. The documentary evidence for meeting the eligibility criteria must mandatorily be submitted along with the offer. If the tenderer the does not submit the documentary evidence along with the offer then the bid shall be dis-qualified.
12. The Financial/Price Bids for the bidder whose Technical Bids found complete and conform the eligibility criteria, shall be opened.

Additional Terms and condition for Solar Street Light

- Bidder must have minimum average turnover of Rs. 1 Cr. Annually for last one Year.
- Warranty of on-site 3 years minimum with fast on call service within 48 hours and 1 year onsite service on torches.
- The supplier shall be responsible for any rectification of problems within the warrant period of minimum 3 (three) years to make the unit fully functional. Replacement of any parts within the warranty period shall be on the part of the supplier
- Bidder should have valid Test Certificate for the tendered Solar Street Lighting System (complete system) issued from a MNRE authorized testing center or NABL accredited Lab
- The tendered luminaires (Light fittings) need to be manufactured in India/Made In India only in OEM's own factory.
- OEM Must have GST registration details in ODISHA against proof of the local availability for technical support & smooth operation of the service against warranty.
- Bidder must submit necessary technical documents such as LM 79, IP Test Report, Impact test report along with the bid document.

14. Valuation of technical proposal:

TSC will evaluate whether all the points/ requirements mentioned in the TENDER DOCUMENT are understood and addressed well. TSC will also evaluate whether the implementation methodology is in line with the requirement. The bidder must make a technical presentation and demonstration of projects on the date of opening of the tender i.e. on **17.10.2024**.

15. To declare a bidder as technically qualified, the bidder has to score a minimum of 70 marks Solar Street Light & 35 Marks Torch light and Gajasathi Logistics & Equipment based on the above said (TES) and the financial bids of only those bidders who score 70 mark & 35 marks or above in the TES shall be opened.
16. The lowest financial bid from those who qualify TES will be termed as L1 and the contract will be awarded to L1 for supply of the items.
17. In case of a tie in financial bids, bid with higher TES will be awarded the contract for supply
18. In case of Torchlight the Tender Scrutiny Committee (TSE) will finalize the specific model of torch based on presentation and suitability of product for use.

Security Deposit

- The supplier should provide the service report the purchaser. 

1. **Solar Panel:** Wattage: 12 V, 150W, Polycrystalline PV module, Warranty- 25 years, MNRE Approved –IEC certified or equivalent
2. **Lithium Battery:** LiFep04 (lithium Ferro Phosphate) Battery with light housing Warranty- 3 year (minimum), warranty assurance certificate to be issued by vendor in case of selection , Approval- BIS Certification.
3. **Pole:** GI Pipe Diameter- 76 mm dia, thickness- 4 mm, Height- 6.5 meters hot dip GI pole (5.5 meters above ground level and 1 meter below ground level), Approval-ISI Certification. The spigot mount for connecting lamp and pole should be adjustable and mounting angel shall be 80°
4. **Installation:** Scope of supply includes installation, commissioning at various locations of Dhenkanal Forest Division within 150 kms of Dhenkanal Forest Headquarters. The seller shall include transportation, GST within the scope of supply. Safety and operational check of the equipment shall be done by the buyer in presence of the supplier before handover. The list of locations for street lights installation will be shared after award of tender.

6. **Motion sensor:** In built with PIR Sensor-10 meters working range, Detection: 102 degrees horizontal 92 degrees vertical. Ability to switch off the PIR sensor when required to activate it in a timebound manner if needed.
7. **Energy saving mode:** Automatic dusk to dawn, on detecting any movement, the LED glows at full brightness. If no movement is detecting for more than 30 seconds, the controller reduces the brightness of LED Lamp by 70%.
