Sealed quotation of Expression of Interest is invited from interested suitable agency/ supplier for providing meal to the participants/ farmers/ officers of Farm Mechanization Mela-2024 of district level and sub-divisional level as per the term and conditions (Enclosed). The bidders/ suppliers are requested to see the terms and conditions for supply of food to the farm mechanization mela-2024. The sealed quotations with all documents should reach the office of the undersigned on or before **19.11.2024 (till 12:00 Noon)** through registered post/speed post/courier service/ hand. The application will not be considered at any cost after last date of submission of quotation (19.11.2024, till 12:00 Noon). The quotations will be opened on dated **19.11.2024 at 3.00 P.M.** in presence of the selection committee. The least quoted vendor/ supplier will be awarded to supply of foods. The undersigned reserves the right to reject/ accept /modify /cancel any or entire quotation(s) fully or partially without assigning any reason thereof.

Food Items to be supplied to the Mela:

1. Rice
2. Dal
3. Mix-veg
4. Khata
5. Pampad
6. Chips
7. Mushroom for vegetarian (30% of total meal)
8. Chicken for non-veg (70% of total meal)

Terms and Conditions:

1. The rate quoted should be inclusive of GST and other related taxes.
2. All items / ingredients used in cooking should be of good quality like FSSAI quality. The meal in each day served within 1.00 P.M.
3. Drinking water, Khali, plate and cup etc should be included in the meal.
4. Transportation, service and supply of food should be included in meal.
5. Must ready with at least 5% extra food to be provided if required.
6. Last date and time of submission of Eoi is on dt. 19.11.2024 till 12:00 Noon.
7. The food supplier shall engage the man power to manage the catering service properly after verifying their antecedent.
8. The food supplier is fully responsible to comply with the food safety, labour and taxation laws in force.
9. The food supplier needs to make adequate safety arrangement for the workers while carrying out the work. The authority will not be responsible for any damage / injury / death etc. caused to any of his / her workman during execution of the work and it will be the sole responsibility of the food supplier.
10. Engagement of child labour is strictly prohibited.



11. The undersigned reserves the right to reject/ accept /modify /cancel any or entire quotation(s) fully or partially without assigning any reason thereof.
12. Any dispute arising in the contract will be mutually resolved and decision of the paying authority will be final.
13. Payment will be made in cheque or through N.E.F.T. after submission of bills and documents etc.
